Following dinner, discussion continued regarding the interaction between Council and staff and the amount of time that is appropriate for Council requests of staff. Council considered getting Caucus questions to staff prior to Monday morning.

Interim City Administrator Tom Crawford presented the City's financial update and plans for the upcoming budget to Council. He also spoke about the City's strategic planning efforts. Other Service Area Administrators updated Council on their work on the priorities set by Council at the 2014 Planning Session. Staff members who presented on the previous year's efforts included Larry Collins, Fire Chief and Interim Community Services Area Administrator; Cresson Slotten, Systems Planning Manager; Nick Hutchinson, City Engineer; and Craig Hupy, Public Services Area Administrator.

Council discussed other priorities that were not included last year, but may need to be included in the upcoming year. Traffic calming was discussed and considered for a possible Work Session topic. Street lighting, flood mitigation and stormwater issues; financial planning and infrastructure management were also discussed. It was decided that a comprehensive look at stormwater and flooding should be considered in the next year, but it would not yet be added to the list of priorities.
