E-1 Estimated Allocation of Expenses for VEBA Administrative / Facility Services

The Board reviewed an analysis provided by Ms. Walker which estimated what portion of System administrative and general costs the VEBA should be charged. The analysis shows that general costs such as facility and maintenance and office supplies are allocated based on the asset value of the VEBA Fund ratio to the overall value of assets, and certain general costs such as postage and printing were excluded as not pertaining to the VEBA.

Ms. Walker noted that the figures may be adjusted in late June when the budget is more complete, and the figures in the estimation are through April and indicate a total of \$42,078.30. The Board discussed whether the Fund should be billed annually or quarterly, and decided that it should be done annually going forward. The Board requested that this item be placed on the June Board agenda so that the numbers can be updated with actual costs for the year and final Board review and decision.
