Moved by Beeson, seconded by White that the Commission issue a certificate of appropriateness for the application at 320 S. Seventh Street, a contributing property in the Old West Side Historic District, to add a basement egress window on the west elevation, as proposed. The work is compatible in exterior design, arrangement, texture, material and relationship to the rest of the building and the surrounding area and meets the Ann Arbor Historic District Design Guidelines, especially those for windows, and the Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings, in particular standards 2, 9 and 10 and the guidelines for windows.

Hall reported that he agrees with the staff report, and while the roof surface might seem large, he felt the drawing is misleading, because one would not be able to see much of the roof section. He felt the addition was well designed and while it was unfortunate they would lose the window in the brick, it would be stepping back and one wouldn't see a lot of it.

Ross agreed, adding that she felt the 2-story addition was respecting the historic house and as the rendering depicts one wouldn't be able to see much of the addition from the street, and she supports the proposal.

Sonia Schmerl, owner, and Michael Bruner, architect and applicant, were present to respond to enquires from the Commission.

The work is compatible in exterior design, arrangement, texture, material and relationship to the rest of the house and the surrounding area and meets The Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings, in particular standards 2, 5, 9 and 10 and the guidelines for additions and building site; and the Ann Arbor Historic District Design Guidelines for additions.
