Zeeb Rd, 2nd floor, Ann Arbor, Michigan 48103.

The Water Resources Commissioner, engineers and other staff members will be available to assist individuals throughout the day, and make revisions where necessary. There is no need to schedule an appointment for a specific time on the Day of Review.

The <u>Day of Review of District Boundaries</u> is for the purpose of reviewing and revising the boundaries of the Drainage Districts below; and is an opportunity to review the Drainage District boundaries with the Water Resources Commissioner or a member of his staff. The <u>Day of Review of Apportionments</u> is an opportunity to review the apportionment with the Water Resources Commissioner or a member of his staff.

Proceedings conducted at this public meeting will be subject to the provisions of the Michigan Open Meetings Act. Information regarding this meeting may be obtained from the Washtenaw County Water Resources Commissioner's Office located at 705 N Zeeb Rd, Ann Arbor, MI 48103.

You may appeal the Water Resources Commissioner's decision to revise the district boundary to the Washtenaw County Circuit Court within ten (10) days, and you may also appeal the determination of apportionments to the Washtenaw County Probate Court within ten (10) days.
