WHEREAS, a current real estate manager, DRA, presented their investment strategies for Fund DRA Growth and Income Fund IX, LLC, to the IPC on August 2, 2016, and

WHEREAS, Meketa and the Investment Policy Committee have recommended an investment with DRA Fund IX, so be it

WHEREAS, Silicon Valley Bank presented their investment strategies for Strategic Investors Fund VIII to the IPC on August 2, 2016, and

WHEREAS, Meketa and the Investment Policy Committee have recommended an investment with Strategic Investors Fund VIII Strategic Investors Fund VIII, as it provides highly concentrated exposure to hard-to-access venture funds, so be it

RESOLVED, that the Board of Trustees approve the investment In Silicon Valley Bank Strategic Investors Fund VIII, with a commitment in the amount of \$2 million, pending review of investment management documents by the Board's legal counsel and any recommended additional due diligence.
