•Be it resolved: The Ann Arbor Public Art Commission recommends that CIP Project TR-AT-13-01 Annual Sidewalk Repair Program has potential for enhancement in the following way: A city-wide competition for the design of cement stamps or embedded medallions with fabrication compliant with ADA requirements, to be used at the discretion of city staff when replacing sidewalks throughout the city. A proposed budget range of \$8K - \$18K is recommended. (Simpson / Smith)

• Be it resolved: The Ann Arbor Public Art Commission recommends that CIP Project TR-AT-11-04 Ann Arbor-Saline Road/I-94 Non-Motorized Improvement has potential for enhancement in the following way: provide an engaging experience through creative design of pedestrian sidewalk and handrails, that could be visible

from the roadway or as a pedestrian. A proposed budget range of 15K - 30K is recommended. (Simpson / Smith)

James Neal - Blue Giraffe & Glass Tiger Donation - New Public Art donation form has been completed and is available online. Commission wishes to experiment with donations and put these two pieces within the community. **Necest, liability covered by Nissan Family,** A permanent donation as part of the City in collaboration with DDA. Discussion re location of these two pieces and a great deal of support from community. These two pieces received the Art Prize award in Grand Rapids.
