A RESOLUTION SETTING THE 2007 WASHTENAW COUNTY MILLAGE RATE FOR PARKS & RECREATION, NATURAL AREAS, HCMA AND EECS 800 MHZ FOR A DECEMBER 2007 TAX LEVY

WASHTENAW COUNTY BOARD OF COMMISSIONERS

October 17, 2007

WHEREAS, the Board of Commissioners previously adopted the 2007 General Operating Millage rate in the amount of 4.5493 on June 20, 2007 in resolution 07-0126 due to the tax levy timing change from December to July for the General Operating millage; and

WHEREAS, the remaining Washtenaw County millage rates must be approved for the December tax levy including Parks & Recreation, Natural Areas, HCMA, and EECS 800 MHz; and

WHEREAS, the County Finance Office, Administration, Corporation Counsel, Equalization, and the Ways and Means Committee have reviewed this matter.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby sets the 2007 Washtenaw County Millage Rate at for Parks & Recreation, Natural Areas, HCMA and EECS 800 MHz based on the 2007 Taxable Value, to be used to levy property taxes for the 2008 Fiscal years, as follows:
