DISCUSSION: Following work done to reduce radon infiltration, a test device was deployed in the Basement (Center), and a post-mitigation test conducted as prescribed by *Protocols for Radon and Radon Decay Product Measurements in Homes*, (EPA 402-R-92-003). The EPA recommends that the average radon levels in a residence be reduced to below 4.0 pCi4.

This test was conducted with Continuous Radon Monitor #1027 - 38991189. Monitors must be calibrated at least once every 12 months; the last factory calibration for this monitor was on 04/26/2016. Our NEHA number signifying proficiency at quality control of CRMs is 100493RT.

Test Period: 09/20/2016 at 11:15am, through 09/22/2016 at 11:15am

Weather: Fair, No Anomalies

Remarks: Radon levels below EPA Action Level, PASS !!!

It is normal for the data tape (attached) to show hourly readings that vary considerably above and below this average, from random variations in radiation decay and because of weather. Higher radon levels are normally found in cold, wet or windy weather.

The EPA recommends waiting for at least 24 hours after the work before beginning the test, to allow the pre-mitigation radon to be cleaned out. Data collected before that time may be discarded before calculating the average.

WHAT TO DO NEXT: Even if your system includes a monitor/alarm (Safety Siren), we and the EPA recommend that you conduct a completely independent follow-up test, ideally with a long term test conducted over at least 3 months and including a balance of both cold and warm weather conditions. "Alpha track" test kits are available from your conty health department and other sources (including Protech) for about \$25.
