Executive Committee meets September 26

SEMCOG's Executive Committee will meet at 1 p.m. on Friday, September 26, 2008, in SEMCOG's downtown Detroit office. Action items to be considered by the committee are as follows:

- approving amendment of two new road projects (and associated funding transfers) and two coordinated human services transportation plans to the 2030 Regional Transportation Plan for Southeast Michigan (RTP);
- establishing a guide for spending transportation funds as a part of Direction2035 — the region's next long-range regional transportation plan; and
- approving the Regional Clearinghouse Review Committee's recommendation to establish a task force to evaluate and recommend revision to SEMCOG's policies related to infrastructure. The purpose is to evaluate and revise policy in light of the region's slower growth and increased emphasis on issues such as asset management.

At the meeting, Susan Mortel, Director of the Bureau of Transportation Planning at the Michigan Department of Transportation, will be the featured speaker, discussing the current state transportation funding situation and the impacts this will have on state and local governments. *Contact: Kathleen Lomako, SEMCOG Deputy Executive Director.*

Traffic down in Southeast Michigan

From 2002-2007, the seven-county Southeast Michigan region has seen a 4.5-6.5 percent decrease in weekday traffic volume. These results are based on an analysis of about 3,000 locations regionwide, through SEMCOG's traffic count program. Weekend or discretionary travel is down another two percent. Although some areas in the region have seen an increase in traffic, the magnitude of decrease is greater. Factors

contributing to the decrease in travel include the economy, high gas prices, and changes in travel choice.

Analyses by national agencies (Federal Highway Administration) and state agencies (Michigan Department of Transportation) also show a decrease in travel at both the national and state levels.

On a positive note, less travel results in overall reductions in fuel consumption, reduced traffic congestion and wear-and-tear on roads, and improved air quality. There are, however, other consequences of these travel decreases that directly impact Michigan roads. Decreases in travel mean that less gas is purchased. If less gas is purchased, then there is less state gas tax money going into the Michigan Transportation Fund, which funds road improvements. In addition to the downward traffic trend, other factors such as improved fuel efficiency, alternative fuels, and hybrid vehicles also contribute to lower gas-tax revenues.

SEMCOG has long been a proponent of finding other options to the gas tax to fund Michigan road improvements. In the short term, we must increase the state gas tax and look for new revenues through state-enabled local taxes and fees. In the long-term, we'll need stable sources of revenue that can efficiently raise enough revenue to address our many urgent transportation needs. The focus of the meeting is to present the Capital Improvement Program for the DWSD Water Supply and Sewage Disposal Systems. The meeting will be held for water customers at 10 a.m.-noon and for
