EIGHTH AMENDMENT TO AGREEMENT BETWEEN DYKEMA GOSSETT AND THE CITY OF ANN ARBOR FOR LEGAL SERVICES

The City of Ann Arbor, a Michigan municipal corporation, having its offices at 100 North Fifth Avenue, Ann Arbor, Michigan 48104 ("City") and Dykema Gossett, with offices at 2723 South State Street, Suite 400, Ann Arbor, Michigan 48104 ("Firm") agree to amend the legal services agreement between the parties originally approved by City Council on April 7. 2003 as follows:

 - III. COMPENSATION OF FIRM

A. The Firm shall be paid on the basis of time spent and expenses incurred at the rates and prices specified in Eighth Amended Exhibit B. The total fee to be paid the Firm for the Services shall not exceed Seven Hundred Fifteen Thousand and no/100 dollars (\$715,000.00) without respect to fiscal year. Payments are to be made monthly following receipt of invoices submitted by the Firm, and approved by the City Attorney. The invoices shall include a detailed report of the Firm's activities for the month.

All terms, conditions, and provisions of the original agreement between the parties approved by City Council April 7, 2003, are to apply to this amendment and are made a part of this amendment as though expressly rewritten, incorporated, and included herein.

This Amendment to the Agreement between the parties shall be binding on the heirs, successors and assigns of the parties.
