SEMCOG releases statistics on deer crashes in Southeast Michigan

There were 6,280 vehicle-deer crashes in Southeast Michigan in 2007 (down from 6,358 in 2006 and up from 6,097 in 2005), according to figures released by SEMCOG. That figure represents 4.5 percent of all crashes in 2007 (140,115 total).

Rochester Hills and Scio Township experienced the most deer crashes in Southeast Michigan in 2007. Those SEMCOG member communities in the top 10 list — Rochester Hills, Scio Township, Independence Township, Orion Township, Oxford Township, Brighton Township, Oakland Township, Washington Twp., Genoa township, and Shelby Township, along with Livingston and Oakland Counties — will each receive, from SEMCOG, a special informational display customized for their community on the dangers of deer crashes, along with "take with" materials for residents.

SEMCOG is a member of the Michigan Deer Crash Coalition (MDCC), working to raise awareness of and decrease vehicle-deer crashes. A press conference will be held in Rochester Hills on September 30. SEMCOG releases combined sewer overflow report

Southeast Michigan has invested \$2.4 billion in projects designed to reduce combined sewer overflow (CSO) pollutant discharges, resulting in an 85 percent reduction in untreated CSO discharges. According to a report just released by SEMCOG, those investments continue to improve water quality and quality of life in Southeast Michigan. The report, Investment in Reducing Combined Sewer Overflow Pays Dividends, was created jointly with the Detroit Water and Sewerage Department (DWSD) and several of its customers,

Federal brownfield grant opportunities available

The U.S. Environmental Protection Agency (EPA) has posted competitive EPA Brownfield grant opportunities for 2009 on its Web site. The proposal deadline is November 14, 2008. These grants may be used to address sites contaminated by petroleum and hazardous substances, pollutants, or contaminants (including hazardous substances co-mingled with petroleum). \$3.9 billion in CDBG emergency funding to local governments

On July 30, 2008, the Housing and Economic Recovery Act was signed into law. Included in this legislation is \$3.92 billion in emergency CDBG grants directed to states and local governments for redevelopment of abandoned and foreclosed homes. The U.S. Department of Housing and Urban Development (HUD) is expected to release the allocation formula and program regulations on September 29, 2008. It is expected that a good percentage of Michigan's funds will be directed to Southeast Michigan as the seven-county SEMCOG region accounted for 74 percent of all foreclosure notices filed in the state in August 2008.
