SEMCOG's elected leaders choose investment direction for next transportation plan

As a part of developing **Direction2035** — the region's next long-range transportation plan, local elected leaders of SEMCOG member communities adopted a guide for spending transportation funds at the September 26 Executive Committee:

- Transit capital 5.6 percent;
- Transit operations 17.9 percent;
- Pavement 23.8 percent;
- Bridges 4.0 percent;
- Congestion relief 7.6 percent;
- Safety 0.6 percent;
- Nonmotorized transportation 0.8 percent; and
- Road operations 39.7 percent.

Combined with an analysis of transportation needs and priorities, this guide will be used by SEMCOG and state and local road and transit agencies as projects are proposed for inclusion in **Direction 2035**.

Investing in this manner is expected to have an overall positive impact on the transportation system. It will result in the continued operation of the existing transit system plus construction and operation of three rapid transit lines; 69 percent of pavement in good or fair condition; 91 percent of bridges in good or fair condition; 2.8 hours of travel delay per 1,000 vehicle miles traveled; 0.74 fatalities per 100 million vehicle miles traveled; 58 percent of people and jobs within one-half mile of a nonmotorized facility; and continued operation of the existing road system.

The Executive Committee further adopted a statement indicating that current funding levels for both highway and transit systems are inadequate to support needed improvements. The resolution supports efforts to raise additional revenues at both the state and federal levels to address needed transportation improvements in Southeast Michigan. SEMCOG and Lt. Gov. Cherry to host meeting seeking input on The Great Lakes Framework

SEMCOG has announced details for an October 20, 2008 meeting it will host to consider Michigan's plan for protecting

and restoring the Great Lakes. At the meeting, Lt. Governor John Cherry and staffs from the Office of the Great Lakes and the Michigan United Conservation Clubs will seek input for the strategic plan for the Great Lakes from individuals and organizations who are actively engaged in Great Lakes restoration, remediation or protection. SEMCOG and its members are recognized as key stakeholders whose experiences and expertise are critical to the success of the initiative. Great Lakes water compact becomes law

Culminating several years of work in Michigan and other Great Lakes states, President George W. Bush has signed a compact designed to prevent Great Lakes water from being diverted to other areas of the country or world. It also requires the region's eight states to regulate their own use. This is the final step in a process going back nearly a decade, when the region's governors began discussing how to prevent other regions from tapping into the lakes. The language was negotiated by the governors and ratified by the legislatures of all eight states, with Congress recently giving its approval. The compact bans diversions of water with limited exceptions for communities near the basin boundary and sets a standard for Great Lakes states to use in regulating water use. SEMCOG advocated for passage of the compact by participating in several groups that helped craft and pass Michigan's legislation as well as securing support in Congress. Ozone action season ends

Ozone Action season ended on September 30. This is the 15^{th} year of the voluntary program that helps keep Southeast

Michigan's air clean. Southeast Michigan had five Ozone Action days this summer, called on July 11, 17, and 18; August 21; and September 2. Thanks in part to citizen support and action, Southeast Michigan is now attaining the ozone standard.
