1. Alissa Beveridge - Safe Streets

Alissa Beveridge, 2651 Geddes, spoke about safe streets and urged Ann Arbor to make crosswalk improvements a priority.

2. Kathy Griswold - Budgeting for Pedestrian Safety

Kathy Griswold, 3565 Fox Hunt, spoke about the recent pedestrian death at Huron High School. She encouraged the public to come speak to City Council at their upcoming planning session and to urge Council to make pedestrian safety a priority in next year's budget.

3. Alan Haber - Library Lot

Alan Haber, 531 Third Street, spoke about his failed Library Lot petition. He stated the First Amendment allows for the right to petition. He urged Council to overturn staff and bureaucracy and place this issue on the next City ballot.

4. Ethel Potts - Honoring Council Member Briere

Ethel Potts, 1014 Elder Boulevard, thanked Councilmember Sabra Briere for her many years of service to the community.

5. Khita Whyatt - Hate Crimes

Khita Whyatt, University of Michigan professor, stated she was a victim of a hate crime. She urged Council and the Ann Arbor community to stand against this type of crime in Ann Arbor, stating it can be very difficult for victims to come forward.

CC COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski addressed the last speaker's comments regarding hate crimes. He urged victims to come forward and to seek help and support.

COUNCILMEMBER KAILASAPATHY

Councilmember Kailasapathy also spoke about the recent reports of hate-based crime in Ann Arbor, stating it is very personal to her, as she is a former refugee herself. She stated she will never vote in favor or support deportation efforts. She stated whether legal or illegal, all persons deserve compassion.

COUNCILMEMBER LUMM

Councilmember Lumm noted that the Ann Arbor Police have maintained a presence at Huron High School during peak hours, and will continue to do so until the lighting is improved at the crossings.

MAYOR TAYLOR

Mayor Taylor addressed recent reports of hate crime in Ann Arbor. He stated Ann Arbor will not stand for hate and bigotry and he commits to continuing to defend the innocent. Mayor Taylor stated Ann Arbor rejects harassment in all forms.
