Hi Letitia,

I'm sorry that I couldn't get to this before our Council vote. I did support the grant match (~\$500,000 for ~\$2.5 million in federal match). The article today focused on the declining ridership in the last four years, and particularly in the last year. I encourage you to check out the Department of Energy's record of gas prices at the pump in that same time (even over the entire 1994-2016 time frame). The correlation is almost exact. Gas prices go up, ridership goes up. The immediate decline in ridership correlates exactly with our near-term oil price decreases -- a result of investment in unsustainable domestic oil.

So that's a direct response to the article itself. Overall though, I believe in a new station. I believe that people select their mode of transit for three core reasons: (1) Cost, (2) Reliability, and (3) Speed. Here are some thoughts on each:

- (1) Gas will get expensive, very expensive.
- (2) MDOT has completed its purchase of all the rail between Detroit and Chicago, giving priority to passengers. This has gotten the Ann Arbor to Chicago Amtrak trip to five hours flat.
- (3) MDOT has also been making incremental improvements to the rail infrastructure itself. By the end of this year, the maximum speed of the Wolverine will increase from 80mph to 110pm, shaving off 30 min of travel time between Kalamazoo and Dearborn.

I hope this helps clarify my thought process and current thinking on the issue. As always, happy to hear thoughts going forward.
