One general observation is that closed captions can obscure scrolling information at the bottom of the screens, often with info that sports enthusiasts want to see in real time. The ordinance could be improved by basing it on preservation of hearing and reducing stress in a public environment, while providing accommodation for those needing hearing assistance. Use science and consistent principles that promote health, safety and welfare.

Why should it be "all" televisions? If only one television, then yes, captioning should be turned on. If two or more, then not less than half. That would be more accommodation than the percentages used for accessible parking spaces. Has it been considered that when closed captioning is on, that volume be off? One of the main problems I've observed is that televisions create noise pollution over which it is hard to be heard in conversation or to hear one television over another turned to a different channel. Noise pollution can also cause hearing damage, general fatigue and stress. The negative effects are exacerbated by the amount of time exposed to high decibels or extreme frequencies. Hearing damage from excessive noise can be temporary or permanent.

How could Ann Arbor pay for all that? CTN's mission needs to be rethought. And the ordinance regulating how cable fees are spent needs some revision.

Instead of asking what's a real problem that needs solving, and requires money to solve, and figuring out how to find the money to solve it, once again the Ann Arbor City Council appears to be opting for a no-cost, non-
