Mayor Pro Tem Chuck Warpehoski called the meeting of the Ann Arbor City Council to order at 7:01 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron Street.

Jessica Prozinski, 446 Larkspur, spoke in support of the proposed ordinance.

William Mayhew, 2751 Maplewood, spoke in support of the proposed ordinance, noting that many undocumented workers are taxpayers.

3. Maria Ibarra - Solicitation of Immigrant Status Ordinance (B-2)

Maria Ibarra deferred her comments until the public hearing on this subject.

4. Alexandra Schulz - Solicitation of Immigrant Status Ordinance (B-2)

Alexandra Schulz, Ypsilanti resident, spoke in support of the proposed ordinance.

Ken Dillen - Resolution to Amend the Old West Side Parking District – Second Street
 (DC-2)

Ken Dillen, 403 W. Liberty, spoke in opposition to the proposed Resolution to Amend the Old West Side Parking District, stating the proposal will greatly reduce the ability for residents to provide visitor parking for their guests.

6. Ethel Potts - Planning Process

Ethel Potts, 1014 Elder Boulevard, expressed concerns about the planning process, particularly with the Hillside Manor site plan process, stating the project should have gone back to the Planning Commission.

7. John Mirsky - Funding for Climate Action Programs

John Mirsky, 505 Burson, spoke about funding for Climate Action Programs and the importance of addressing global warming.

8. Hugh Garton - Property Tax on Solar Panels

Hugh Garton, Ward 2 resident, expressed frustration with the City Assessor's policy regarding solar panels. He stated the City's tax policies regarding solar panels make it cost prohibitive to install solar panels for energy efficiency and conservation.

CC COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER KAILASAPATHY

Councilmember Kailasapathy spoke about the recent emails Council has received from the public regarding the Library Lot development. She noted that the DDA has recently provided Council with information that there are over 2000 people on the waiting list for parking spaces in the downtown. She also expressed concerns about the City developing this site while a federal audit is ongoing regarding the use of the Build America Bonds on this project. She requested that Council hold a public hearing prior to developing this site.

COUNCILMEMBER ACKERMAN

Councilmember Ackerman stated he supports a public hearing on the Library Lot site, but noted that the recent Work Session did include over three hours of public testimony. He also spoke about the importance of the contribution to affordable housing that this project brings to the community.

COUNCILMEMBER EATON

Councilmember Eaton spoke in favor of holding a public hearing on the Library Lot, stating that if the City is going to sell public land, the public should be able to provide their input. He also noted that the revenue to the affordable housing fund is a one-time fix. He stated Council should find a way to fund affordable housing on an ongoing basis.

COUNCILMEMBER GRAND

Councilmember Grand stated the proposed Library Lot development has been discussed for nearly ten years. She stated that a public hearing isn't necessary, as this issue has been debated for ten years.

COUNCILMEMBER WESTPHAL

Councilmember Westphal spoke about the City's publicly owned land in the downtown and the number of projects the City has coming up besides the Library Lot site.

COUNCILMEMBER LUMM

Councilmember Lumm also addressed the development of the Library Lot.

Councilmember Lumm stated she would also support holding a public hearing on this issue.

MAYOR PRO TEM WARPEHOSKI

Councilmember Warpehoski replied to the comments regarding the Library Lot. He also addressed the comments about solar panels and property taxes. He stated the City Assessor has his own discretion to assess property values. He did note that a legislative change might be in order to address the issue and set policy.
