PUBLIC UTILITIES EASEMENT AGREEMENT FOR GOLFVIEW LANE 2004

KNOW ALL PERSONS BY THESE PRESENTS: That THE REGENTS OF THE UNIVERSITY OF MICHIGAN, a Michigan constitutional corporation, with its address at 326 E. Hoover Street, Ann Arbor, MI 48109-1002, hereinafter called Grantor, hereby grants and conveys to the CITY OF ANN ARBOR, a Michigan municipal corporation, with its address at 100 North Fifth Avenue, Ann Arbor, Michigan, 48104, hereinafter called City, a permanent easement for the construction and maintenance of waters mains, storm sewers, sanitary sewers and appurtenances thereto, all of which are hereinafter referred to as a public utilities system, along with the public utilities system presently within the following described premises, situated in the City of Ann Arbor, County of Washtenaw, and State of Michigan, being more fully described as:

- (d) Grantor agrees to hold the City harmless from all claims, made by persons not a party to this agreement, when said claims occur or accrue to said persons as a result of water escaping from water mains under conditions set forth in paragraph 4(c).
- Due to the as-built conditions in and around the Easement Area, the City agrees that, before it repairs or replaces the public utilities system in the Easement Area, the City will notify Grantor of its repair/replacement schedule and allow Grantor an opportunity to comment on the work plan for the limited purpose of construction safety measures to avoid damage to adjacent foundations, buildings, footings and similar types of structures in the Easement Area. As to the Easement Area and to the extent permitted by law, the City agrees to indemnity and hold Grantor harmless from any and all claims, loss or damage arising out of the failure or negligence of the City, its employees, agents or contractors, in connection with the activities authorized under this Easement except when such claims, loss or damage are due to or chargeable to, in whole or in part, any alleged active or passive negligence or participation in the claim, loss or damage by Grantor or as otherwise provided herein. Notwithstanding the above, the City reserves its right to assert any and all defenses it may have, whether statute or common law, including but not limited to governmental immunity.

To the extent permitted by law, the City shall indemnify and hold Grantor harmless from any and all claims that arise from the City's activities authorized under this Easement (including those of its employees, agents and contractors) except as otherwise provided herein.

This grant of easement shall run with the land and shall be binding on and shall inure to the benefit of the parties hereto, their successors, heirs, executors and assigns, unless and until amended by written agreement of the parties.
