#### UNFINISHED BUSINESS

Annual Renewals

City Clerk Jacqueline Beaudry updated the committee that letters were sent to the six businesses identified previously by the City Treasurer for delinquent invoices or delinquent personal property taxes:

Ashley's Restaurant Banfield's Bar and Grill BurgerFi Nagomi Sushi and Noodles Old Carolina Barbecue Company Sabor Latino

Deputy Treasurer Mike Pettigrew reported that Sabor Latino paid their outstanding invoice and he was removing his objection to their renewal.

The committee discussed BurgerFi's delinquent tax bill in the amount of \$17,604.61. Mr. Pettigrew noted that he had previously spoken to this licensee about filing a personal property statement with the City, noting that the owner has not done this so his taxes are based on the City's estimate.

*Lt.* Bush of the AAPD stated that the Police Department does not have any objections this year.

Glen Dempsey, the City's new Building Official, arrived at 12:20 p.m. Mr. Dempsey provided the committee with a number of new objections from the Building Department, following his review. Assistant City Attorney Fales suggested that the committee table the Building Department reviews until next year due to the late date. There was general consensus that Mr. Dempsey could provide his recommendations during next year's review if issues are not addressed in the coming year.

Following further discussion, Smith moved, seconded by Westphal, that the Committee proceed with recommending to Council that a hearing be scheduled for Wednesday, February 22, regarding the remaining five objections from the City Treasurer. On a voice vote, the motion carried.

It was decided that the City Clerk would send letters to the five licensees alerting them of the next steps with a final deadline to pay of Friday, February 3 to avoid being included in the February 6 City Council resolution setting a hearing to consider non-renewal.

Edward Vielmetti, Fourth Ward resident, speaking on behalf of Damn Arbor asked for clarification that the February 6 City Council meeting would include a resolution to schedule the hearings for non-renewal of liquor licenses. (A member of the committee replied in the affirmative.)
