Fire Chief Larry Collins, Emergency Manager Rick Norman, Police Chief James Baird, City Administrator Howard S. Lazarus, and other City staff were present to discuss the City's plan for emergency preparedness. A copy of the presentation, Emergency Preparedness Issues and Considerations, is on file in the City Clerk's Office.

Chief Collins led the discussion and introduced other staff members to discuss their individual roles.

Assistant City Attorney Mary Fales spoke about the Mayor and City Council's roles and responsibilities in an emergency event, including a review of changes to Chapter 15 of the City Code.

Lisa Wondrash, Communications Director, explained the role of Communications in an emergency, stating she would act as the City's Public Information Officer. Ms. Wondrash talked about the importance of a single point of contact for information dissemination. It was also noted that the Mayor serves as the spokesperson for the City in an emergency.

Each of the City's Service Area Administrators and department leaders, including Finance, Public Services, Community Services, Police and Communications discussed their roles.

Chief Collins led the group in a tabletop emergency management scenario, requiring participants to respond and react to various situations and circumstances.
