CALL TO ORDER

Mayor Taylor called the meeting of the Ann Arbor City Council to order at 7:02 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron Street.

MOMENT OF SILENCE

Council stood for a moment of silence.

PLEDGE OF ALLEGIANCE

AC COMMUNICATIONS FROM THE CITY ADMINISTRATOR

City Administrator Howard S. Lazarus presented his written reports to City Council and also reported on the following:

Mr. Lazarus noted the upcoming change from Daylight Savings Time to Eastern Savings Time on Sunday, November 5, 2017.

Mr. Lazarus noted that the upcoming November 7 City election would be the last odd-year City Council election and would be for a three-year term, as Council transitions to 4-year terms in even-year elections.

Mr. Lazarus also informed the public that the City Clerk's Office would be debuting new voting equipment at this year's election. He stated an open house would be held at the Center for Independent Living from 1-4pm on Friday, October 20 to introduce the new accessible voting terminal to the disability community. The new voter assist terminal will use a number of tools to make voting accessible for all.

Mr. Lazarus thanked Sgt. Jeff Tabeling and Police Officer Skyler Verhelle for their attendance at tonight's meeting.

Mr. Lazarus reminded the public to look out for the City's young residents on Halloween during the City's trick-or-treating hours on Tuesday, October 31.

- 1. Margaret Leary Move Money for Deer Management (CA-16)

Margaret Leary, 1056 Newport, spoke in support of CA-16, and urged the City to continue with the increased culling efforts and to move budget funds from next year to this year in order to fund the effort.

2. Robert McGee - Deer Budget (CA-16)

Robert McGee, 2245 Placid Way, spoke in opposition to CA-16, and expressed his frustration with the City's deer cull plan.

3. Sally Daniels - Deer Cull (CA-16)

Sally Daniels, 1847 Packard, spoke in opposition to CA-16 and the increased budget to be allocated for this year's upcoming deer cull.

4. Kurt Sonen - Deer (CA-16)

Kurt Sonen, 314 Huntington Drive, Ward 2, thanked the Council for their efforts with deer management. He also noted that he has found three deer ticks in his yard.

5. Lisa Abrams - Deer Management (CA-16)

Lisa Abrams, 2745 Ember Way, spoke in opposition to CA-16, and the proposed increased deer cull efforts.

6. Sabra Sanzotta - Deer (CA-16)

Sabra Sanzotta, 3087 Glazier Way, treasurer for Non-Lethal Deer Management, spoke in opposition to CA-16, and the increase in the City's deer management program.

7. Sarah Byers - Deer #50 (CA-16)

Sarah Byers, 1308 Traver, Ward 1, spoke about deer #50, one of the sterilized deer, expressing concern that this deer may have been traumatized by the sterilization process.

8. Christopher Dick - Deer Budget (CA-16)

Christopher Dick, biologist from the University of Michigan, spoke in support of CA-16. He spoke about the growth rates of white-tail deer and stated increasing the cull now, versus later, is better.

9. Henry Vanderploeg - Safety and Solar Panel Energy Systems (C-2)

Henry Vanderploeg, 2808 Brockman, spoke in opposition to ground-mounted solar panels. He expressed concern regarding safety, including sharp edges, electric voltages, and heated panels. He urged Council to vote against this ordinance.

10. John Godfrey - Zoning Ordinance for Solar Panels (C-2)

John Godfrey, 2809 Brockman, spoke in opposition to C-2, regarding ground-mounted solar arrays. He expressed concern about safety. He urged Council to limit solar panel installation to rooftops, or at a minimum to backyard only. He stated not all spaces are appropriate for solar installation.

CC COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER SMITH

Councilmember Smith asked to have the Medical Marijuana Licensing Ordinance taken from the table and discussed this evening.

COUNCILMEMBER ACKERMAN

Councilmember Ackerman also spoke about medical marijuana and stated the Planning Commission is currently debating the Zoning Ordinance amendments related to medical marijuana facilities.

Councilmember Ackerman spoke in support of CA-15, Human Services Funding.

COUNCILMEMBER EATON

Councilmember Eaton spoke about the Packard Square project, stated the project had been put in receivership. He stated McKinley has been given the project under the receivership and the original developer has filed for bankruptcy in an attempt to get the project back.

Councilmember Eaton also stated the Safe Routes to School grant resolution that was approved at the October 2 meeting was not submitted in a timely manner and the grant application will have to wait for the next round of approvals.

COUNCILMEMBER WESTPHAL

Councilmember Westphal spoke about pedestrian safety and the need for improved road design and speed reductions in order to address this issues.

COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski urged City Council to participate in the upcoming City/Council blood drive on October 20, noting that a friendly

competition, the "blood battle" has been created between the City Council and the County Commissioners.

Councilmember Warpehoski also addressed the fact that several Councilmembers kneeled during the pledge of allegiance this evening. Councilmember Warpehoski outlined his reasons for taking a knee and stated he feels that "taking a knee" is a sign of respect.

COUNCILMEMBER LUMM

Councilmember Lumm also spoke about pedestrian safety issues and the recent pedestrian accident on Huron Parkway near Huron High School. She stated increased Police enforcement is needed on Huron Parkway and Fuller Road during peak school traffic hours.

COUNCILMEMBER KAILASAPATHY

Councilmember Kailasapathy addressed her reasons for "taking a knee" during the pledge of allegiance.
