#### Success Stories

**Stadium Boulevard Reconstruction Project winner of 2017 APAM/MDOT Asphalt Paving Award.** Cadillac Asphalt, LLC, Rawsonville Plant, City of Ann Arbor and Parsons Brinkerhoff will receive an Award of Merit at this year's Asphalt Pavement Association of Michigan (APAM)/MDOT Asphalt Paving Awards program for its work on the Stadium Boulevard Reconstruction Project. Congratulations to Craig Hupy, Nicholas Hutchinson, Michael Nearing, and Public Services/Engineering staff for their excellent work!

Over this past weekend, crews from Public Services responded to a seep at the Barton Dam embankment and a water main leak on Sunset across from the Water Treatment Plant. Interim measures have been taken to ensure continued water supply to our community.

#### **Council Priorities/Initiatives**

**Independent Review of Ann Arbor Police Department Community Engagement Practices**. The City and the Human Rights Commission held a work session on Thursday, Nov. 16 to discuss the report. The report is available via Legistar and posted on the <u>City Administrator's AAPD Community Engagement Practices</u> web page.

The **Zoning Ordinance Re-Organization (ZORO)** project is making its way to the Planning Commission in December, with Council consideration shortly after the New Year.

  - A Public Hearing/Resolution to Approve the 1140 Broadway Brownfield Plan

## WIP (Work in Progress)

Staff has completed the revision to the City's **Green Fleet Policy.** The revised document will be sent to the Energy Commission and Environmental Commission for review and input.

The City is pursuing a pilot with **SnowBuddy** under the micro-grant program to provide sidewalk snow clearing for mobility-challenged citizens and low-income seniors to ensure connections to transit stops are maintained during inclement winter weather.

## Other

**Thanksgiving Day Holidays.** City municipal offices will be closed on Thursday and Friday, Nov. 23-24 in observance of the Thanksgiving Day holiday. There will be no trash, recycling or compost collection services in the city of Ann Arbor on Thanksgiving Day, Thursday, Nov. 23. The normal Thursday pickups will occur on Friday, and the normal Friday routes will be serviced on Saturday, Nov. 25, this week only. Safety services and utility operations will maintain 24-hour schedules throughout.

**Seasonal Compost Pickup.** The seasonal curbside pickups of compostable materials will end for the growing season on Friday, Dec. 8, 2017. Ann Arbor's compost collection provides an opportunity for pickup of fall leaves and other yard debris that have been placed on lawn extensions in paper bags or compost carts or tied into brush bundles, as described online at <u>a2gov.org/compost</u>.

Recycle Ann Arbor's Drop-off Station at 2950 E. Ellsworth Road will be closed Thanksgiving Day, Thursday, Nov. 23. The Drop-off station is regularly open weekly on Tuesdays and Thursdays 8:30 a.m.–6:30 p.m., and Saturday 9 a.m.–6 p.m.

**Sign Ordinance Updates.** The City of Ann Arbor is updating its sign ordinance to include new and innovative sign standards that reflect evolving technologies and approaches as well as a general update

of sign regulations. Two public meeting have been held seeking public feedback. A third public meeting is scheduled on Wednesday, Dec. 13 from 9 – 10 a.m. at the DDA, 150 S. Fifth, Ann Arbor, MI. The project consultant Giffels Webster, has set up an online feedback platform called <u>PictureThis™</u> to better understand how residents and business owners think the current sign ordinance is working and what may need work. As they are out and about in Ann Arbor, the city urges the public to look for the signs they view as particularly effective and attractive — or conversely — ineffective. Images can be submitted to <u>PictureThis™</u> from any internet browser via phone, tablet or computer by clicking the blue "what do you think?" button once on the PictureThis™ site.

**City of Ann Arbor Citizens Academy.** With the success of the Ann Arbor Citizens Police, Fire, and Courts Academy, the City of Arbor will launch an Ann Arbor Citizens Academy (A2CA) this spring to provide a broader view of local government for Ann Arbor residents.

During a series of six weekly sessions, from March 28 to May 2, 6:30–8:30 p.m., participants will connect with city staff and elected officials and learn more about long-term city planning efforts, day-to-day operations and the importance of civic involvement. Session topics include: Finance and Budgeting; Voting and Elections; Parks and Recreation; Planning and Preservation; Public Works; Engineering; Sustainability; Water Quality; Police Services; Fire Services; Community Television Network; and City Council. The class will culminate with a graduation ceremony on May 7, 7–8:30 p.m.

Applications to participate are due by 5 p.m. Friday, March 2, 2018. There are two components to the application process. All applicants must complete and submit an <u>online application</u>.
