Shelly Edgerton, Executive Director for the State of Michigan Licensing and Regulatory Affairs (LARA), updated City Council on the State's Medical Marijuana licensing process. She stated over 700 applicants are in some stage of the application process for a State license.

Ms. Edgerton stated HB 5144 would formalize LARA's ability to create an advisory panel for Medical Marijuana licensing.

Kirk Profit, from GCSI, the City's lobbyist, updated City Council on other legislative matters in Lansing. He spoke about solar panels and the issue regarding the assessment of property taxes on them under current law. There was also discussion regarding elections, transportation issues and environmental concerns.

A copy of the City Administrator's report regarding the legislative agenda and Council policy priorities is on file in the City Clerk's Office.

Edward Vielmetti, 1210 Brooklyn, spoke about the City's lobbyist from Governmental Consulting Services, Inc., stating that Mr. Profit also lobbies on behalf of other jurisdictions, including those in Macomb County whose priorities do not always align with Ann Arbor. He suggested this might create a conflict.
