C-1 Project Update - Environmental Assessment

The Airport Manager reported that the City continues to work to finalize a scope of service with an outside consultant to provide assistance in completing the revised draft Environmental Assessment for the proposed Runway Safety Extension Project. The proposed scope was provided to the FAA for review before the grant request is submitted to the Michigan Aeronautics Commission for consideration. We were unable to meet the agenda deadline for the Commission's March meeting and hope to have the grant request in place for their next meeting in May. The grant agreement must be approved by the Commission before it is sent to City Council for consideration.

C-2 Other Items

The Airport Manager reported that Charles Smith, the FAA's ATCT Manager for Ann Arbor for the last nine years, transferred to a new position within the FAA last month. The new ATCT Manager is Charles Hopkins and he hopes to attend an upcoming Committee meeting to introduce himself. The EAA's annual pancake breakfast is scheduled for June 10th. The roof recoating project for the Alpha row hangar is scheduled for late April-early May depending on weather. With the new digital NOTAM Manager that the airport is using, we have the ability for interested parties to receive email notifications instantly whenever a NOTAM is issued, updated or cancelled at ARB. The availability of this new service is being transmitted to our tenants via the back of bill notice.
