Mayor Hieftje called the meeting to order at 7:03 p.m. in the Guy C. Larcom Jr., Municipal Building, 2nd Floor Council Chambers, 100 N. Fifth Avenue.

Shoshana Hurand, Festifools Co-director, introduced a video of the history of the Festifools. She thanked the City for all of their support of the event, including staff assistance preparing for the event each year. The event this year takes place on Sunday April 5 from 4-5 p.m. Mayor Hieftje was presented with the 2008 Festifools Book by a Festifools puppet made in the likeness of him.

Resolution Supporting Safe Passage Great Lakes Days

Sponsors: Teall, Hohnke, Smith and Taylor

Will Weber, representing the Washtenaw Audubon Society, talked about the project "Safe Passage - Great Lakes". This is a project to protect the passage of migratory birds. The project will also save energy and resources while protecting migratory birds. Mr. Weber explained the problem of tall, lighted buildings and the number of bird deaths they cause at night during the migration. Ann Arbor has enough tall lighted buildings to be concerned about this issue.

Mr. Weber gave a brief slide presentation on the subject. He said that there are about 250 species of migrant birds that fly through the Ann Arbor area essentially unnoticed because they fly at night. Because the birds use the stars and the moon to navigate, they can become confused and misguided by lighted buildings. Collisions with windows are one of the biggest causes of mortality in migratory birds after feral cats. Mr. Weber encouraged everyone to reduce or eliminate the lighting of the upper floors of tall buildings between March 15 and May 31 and again between August 15 and October 31.

- 1. Barbara Bergman Waterfall at City Hall

Barbara Bergman, 1307 Culver, addressed Council regarding a number of issues. She advised Council of a huge pothole that she drove into on Stadium Blvd. near St. Francis and lost a hubcap. She expressed concern with the construction proposed regarding the Stadium bridges improvement project. She said that there will be long traffic lines from Ann Arbor to Ypsilanti. She asked that the City figure out ways to improve both sides of the bridge so that there are two lanes of traffic in each direction. She also expressed concern with the laying off of police officers and questioned how the City could spend money to design a waterfall in front of City Hall.

2. Thomas Partridge

Thomas Partridge, Scio Township resident, said that Washtenaw residents deserve nondiscriminatory regional public transportation. Senior citizens and disabled persons deserve lower cost/free transportation. David Nacht (AATA), President Mary Sue Coleman (U of M) and John Hieftje (Ann Arbor) must act to stop historic discrimination in public transportation.

3. Henry Herskovitz - Palestine

Henry Herskovitz, 404 Mark Hanna Place, addressed Council regarding Palestine. He said that today marks the 6th anniversary of the murder of an American citizen, Rachel Corey, by a foreign government in Palestine. Mr. Herskovitz said that Council can help by asking the Human Rights Commission to reinstate their 2003 resolution calling for an end of USA aid to Israel and help promote the boycott of Israeli investments and sanctions campaign against Israel by becoming a member of the People's Food Co-Op and casting a vote for him in the up-coming elections.

4. Tom Wall - U of M

Tom Wall, 1011 S. Main, passed out t-shirts from the All Star Hotdog Stand to councilmembers. Mr. Wall thanked Council, the Mayor and staff for listening and being sensitive to the needs of his students and their hotdog stand operation.

5. Elizabeth Elling - Allen's Creek Greenway Conservatory

Elizabeth Elling, 1402 Maywood, addressed Council regarding the Allen's Creek Greenway Conservancy. She encouraged Council and the citizens to learn about and embrace the greenway plans. She stated there is great opportunity right now to make this happen.

6. Peter Stark - Proclamation for Peter "Madcat" Ruth Day (INT-3)

Peter Stark, resident of Whitmore Lake, addressed Council regarding the proclamation for Peter "Madcat" Ruth Day. He said that he has known Mr. Ruth since 1971 and it has been a great pleasure to know him. He hopes that he will continue to play music for us for another 38 years.

7. Richard Derrick - Graffiti & Vandalism

Richard Derrick, 415 High St., addressed Council regarding graffiti and vandalism in Ann Arbor. He said that he walks regularly on Detroit Street in Kerrytown and he noticed that vandals are knocking over electrical phone boxes and also tearing off down spouts at the Farmer's Market. They have also knocked down street signs and put graffiti on the wall just north of Zingerman's on a regular basis.
