# CITY OF ANN ARBOR ELECTION COMMISSION RESOLUTION TO CONSOLIDATE PRECINCTS FOR THE SCHOOL BOARD ELECTION TO BE HELD ON TUESDAY, MAY 5, 2009

Whereas, The City of Ann Arbor has determined that a local election will be held in the City of Ann Arbor on Tuesday, May 5, 2009;

Whereas, The City of Ann Arbor has determined that precinct consolidation would be appropriate for this election because of an anticipated low voter turnout; and

Whereas, Ten polling locations have two precincts located in the building for each site that could easily be consolidated causing minimal inconvenience to the voters; and

Whereas, MCL 168.659 allows for the City Election Commission to consolidate two or more precincts in local elections, provided the new consolidated precinct does not exceed 5,000 registered voters;

RESOLVED, That the City of Ann Arbor Election Commission hereby directs the City Clerk to conduct said School Board Election on Tuesday, May 5, 2009 by consolidating the following precincts for this election only, recognizing that consolidation is possible without splitting any precincts or relocating any voters from their usual polling location:

- 1-1 and 1-2 Michigan Union
- 1-5 and 1-6 Northside School
- 1-9 and 2-6 Clague Middle School
- 2-3 and 2-4 Angell School

3-1 and 3-2 East Quad

3-4 and 3-7 Allen School

3-6 and 3-9 Scarlett Middle School

4-4 and 4-8 Pioneer High School

4-7 and 5-7 Dicken School

5-4 and 5-5 Slauson Middle School
