Re: Concerns regarding proposed SEU for Rainbow Childcare Center on Nixon Rd.

We are writing to express our concerns over the city's proposed Special Use Exemption for the Rainbow Childcare Center on Nixon Rd. We have been kept up to date on the ongoing process for this through our City Council representative, Jane Lumm. She has been diligent in attempting to represent the concerns of her ward regarding this issue to the city. Given her diligence, it is very disappointing that she learned of this issue resurfacing only by very recently seeing in listed on the agenda of the August 21 Planning Commission meeting and had not been notified of this personally. This was despite her multiple requests to the Planning Commission to be kept advised of the status of the SEU request because of its potentially negative impact on residents in her ward living very close to this proposed project. The surrounding residents were also not made aware of this item by being placed on the agenda again by the city, nor was AAPS made aware. This is also disappointing as they certainly are another party which would suffer negative impact from this project. The timing of the meeting was unfortunately scheduled on short notice and at a time of year when many residents take vacations. This is the case with us. We do hope you will consider the contents of this letter as we are not able to attend the upcoming meeting to express our concerns in person, nor will Jane Lumm be able to attend. We appreciate that she was able to learn of the meeting enough in advance to notify us in time to be able to provide written communications to you.

We have lived in our current home for the past 24 years, which is located on the corner of Bluett and Shefman Terrace, directly across from the front of Clague Middle School. The volume of traffic on Bluett has increased dramatically since we first moved into our home and most significantly increased over the past 5 years. In the past, most students at Clague walked to school, or rode the school bus. Now it appears that based on the very significant amount of traffic along the length of Bluett and on our own street at the start and end of the school day, that the majority of students are driven to school. Cars are parked along the entire circle drive of Clague, and along both sides of Bluett for several blocks, leaving only lane of cars able to move between the parked cars. Cars are also routinely parked along our small street which no access other than the one end on to Bluett. We have had our mailbox run down three times in the past year with cars backing into and out of ours and neighbors' driveways as they turn around and then attempt to pull out on to Bluett. The lines of cars attempting to turn from Bluett on to Nixon in the morning and after school can stretch several blocks so that getting into and out of our street and our neighborhood at those times can be nearly impossible. Given

the current school traffic and the increased volumes of traffic on Nixon Rd. due to the surge in building north of us on Nixon Rd. adding the volume of traffic a very large childcare would generate to this already congested area, would pose not only added difficulties for cars and school buses attempting to move in and out of the Clague complex, there are also grave safety concerns for those students attempting to cross Bluett and Nixon on foot. Cars waiting in line to turn south on to Nixon are often so frustrated, that they are attempting U turns on Bluett to travel east to get out of the neighborhood and this is being done as students run across Bluett from their parents cars to get to school. Students are also attempting to cross at the Bluett-Nixon intersection at a crosswalk very near to the turn out from Clague St. which is one of the proposed exits from Rainbow Center. Given that most families dropping children off at the daycare center will be driving their children (not walking with them), hurrying off to work and attempting to turn left on to Nixon, it almost certain that a child will be hit by a car as exiting cars attempt to squeeze into any small spot they can find in the south bound lane. This cross walk does not have a light or a stop sign and is marked only with the reminder signs to stop for pedestrians. Those students attempting to cross most likely will not be easily seen by parents exiting the childcare center.

The development of our area has increased dramatically since the original SEU was granted for the church which sits on the proposed Rainbow Center site. There was significantly less traffic on both Nixon and Bluett at that time and the hours of high volume traffic for the church were over the weekends, did not conflict with high traffic volumes for the school during week days. It is an illogical argument that because a previous SEU was granted for this site for the church many years ago, that another should be granted for a very large childcare center now . There is no comparison between development and traffic of this area between then and now, and no comparison between the high traffic volume times of the church and childcare center and their compatibility with school traffic times.

It often seems the city is so driven to press forward with so much new development that they do not give proper and due consideration to the current tax paying residents and the concerns they have for their neighborhoods. We hope that you will listen to our views as you make your decisions. Given the safety issues this project would present for resident pedestrians and students at Clague, and the complete traffic gridlock that would result in area already very challenged by high volumes of traffic we sincerely hope that you will make the wisest decision and deny Rainbow Childcare Center's request for a Special Exemption Use at the proposed Nixon Rd. site. As a parent myself, I realize that quality childcare is important to communities and the northeast section of Ann Arbor is no exception. However, this site is not a safe, traffic logical, or appropriate one for a childcare facility. We appreciate ongoing information regarding this project be shared in a timely and appropriate way with council woman Lumm, us and the other residents of our impacted neighborhood. Thank you for your consideration.

To my Fellow Ann Arborites,

Each morning I enjoy sitting outside on my front porch to watch the birds and annoying squirrels. The sun rises and peaks through the neighborhood trees and the rest of the world go by. It is a delicious time of the day. Excepting that this year. Even now as I write this traffic and construction noise can be heard amidst the birds and bugs.

When I heard from Jane Lumm about the proposed Rainbow Childcare Facility coming back to the table, rather under the radar, I thought, how sneaky and cunning. They will do whatever necessary to get this into our neighborhood. Our neighborhood. Not their neighborhoods. Why might this be true I ask myself.

For some very simple and obvious reasons. One being traffic. Adding into the mix of the normal traffic will be families of up to 180 children, quickly dropping off their babies and young children. They will then follow suit of hundreds of others making the mad dash to get to work. May I take this moment to remind you that recently three major housing developments were also added into our neighborhood just north of this proposed site? There is no way that traffic is accounted for in current traffic studies. How could it? There is no way to know exactly the ramifications along Nixon, Bluett, or Green. Two, childcare facility noise. Now I realize they will not all be outside at once, but the noise of multiple children can, at times, be enough to drive a parent or neighbor crazy. Dear Planning Commission,

I am a Ann Arbor community member who resides in OHMHA. I'm writing to provide full support and encouragement for the development of Rainbow Child Care Center off of Clague Street. I recognize that some community members are opposing this proposition. However, we fully support the idea for several reasons.

- 1. There is s serious shortage of child care centers in Ann Arbor for infants, toddlers, and school age before/after care. As a person with small children ages 4 and 6, I can directly speak to how difficult it is to secure childcare in Ann Arbor. Having Rainbow CCC in our community would provide a valuable and needed service, especially with the expansion of our community from all of the new residents moving into the area from the Toll Brothers North Oaks town homes project.
- 2. Community and PTO members are citing "traffic concerns" as a reason not to support the Rainbow CCC project. However, the addition of the car traffic from the Toll Brothers North Oaks projects actually poses a much more serious traffic risk to our AAPS Clague students than does a child care center located Clague St. Acvirding to Mlive, there will be 472 new residents traveling down Nixon Rd and passing Clague Street/Clague Middle School once the Toll Brothers North Oaks project is complete. This amount of traffic increase is a much bigger problem than the minor traffic that will be brought by Rainbow CCC. https://www.google.com/amp/s/articles.mlive.com/news/ann-arbor/index.ssf/2016/07/nixon road development 1.amp
- 3. My husband and I were notified on July 3rd in writing that the neighborhood elementary school in the OHMHA area (Thurston Elementary) just eliminated before and aftercare childcare for the 4 year old preschool program. My husband and I were told by the AAPS director of curriculum (Dawn Linden) and the acting executive assistant to Dr. Swift (Amy) that we need to "explore other options" for before and after school childcare for our 4 year old student since the school will not be offering this service any longer. If it is not possible for us to keep all of our children together at Thurston for before and after school care, it would at least be nice to have a childcare resource in our own neighborhood.
- 4. If the Lutheran Church property is for sale and rezoning is being considered, wouldn't it be great to have a facility there that is open limited hours (closed on evenings and weekends)? In my opinion, a childcare center is a much more desirable option than another housing development, a retail store, a restaurant, or any other facility that exchanges money for goods or services. At least with a childcare center there, we can preserve quiet hours in our neighborhood on weekends and evenings since the center will be closed at those times.
- 5. Finally, community and PTO members are citing "traffic and safety concerns" as there reason for opposing Rainbow CCC on Clague Street. What actuarial data do these individuals have to validate their stated concerns? Has anyone taken the time to collect data through traffic studies, or safety studies? Has anyone reviewed operational and safety guidelines for roadway facilities around schools, or requested input from a civil engineering firm? Wouldn't it make the most sense to make this important decision using evidenced based approaches that are supported by science, facts, and expert opinions versus relying on fear or personal opinion?

I am writing to express my strong opposition to the Rainbow Childcare Center adjacent to the Clague Middle School.

The revised application submitted by the Rainbow Childcare Center has not addressed any of the issues that the City Council and residents raised earlier this year.

The Nixon/Clague/Bluett area in NE Ann Arbor is already a very congested area during the peak hours, and Rainbow has not addressed safety of pedestrians and children. They are proposing to use only the Western side of the property leading to the "Clague" street and block the Eastern site. This means all cars will have to pass through the "Clague" Street.
