To the Planning Commission:

As a northeast Ann Arbor area parent and president of the Clague PTSO, I am writing to express alarm, disappointment, and incredulity about the return to the table of the proposed Rainbow Childcare Center adjacent to Clague property. It is the wrong business for the wrong place at the wrong time. Here are my concerns:

- 1. Once again, you--together with the Rainbow Childcare Center-- have deviously chosen to push this illadvised proposal forward when the least number of affected constitutents are available to process and respond to the information. Previously, you brought it up just before the winter holidays, and now, in late summer, when many take vacations. Please remember that in this space, approx 1700 AAPS students (roughly 10% of the total) reside. This is clearly designed to make a more democratic process difficult. Do you really want to deal with a "Childcare Center" that shows so little concern for the children and families already living in the neighborhood? Are these sly dealings in the spirit of Ann Arbor?
- 2. Once again, you have not pursued due diligence in fully informing AAPS of these new developments. Mr. Che Carter, current principal at Clague was not contacted directly. Dr. Swift tried repeatedly to contact Rainbow since the matter was tabled back in February, and was not successful. Is this the kind of business you think will be good for this residential corner of Ann Arbor? According to the trip rate estimates from the ITE (Institute of Transportation Engineers) Trip Generation Manual, 90 additional cars will go in and out during weekday morning peak hours (7 am to 9 am), and 95 per afternoon peak hour (4 pm 6 pm). Ninety cars, in addition to the already overwhelming traffic volume generated by the other three schools in close proximity! How can you claim that, as is stated in criterion #3 of the petitioner's "Special Exception Use" requirement, the proposed center "will be consistent with the general character of the neighborhood considering population, density, design, scale and bulk; and the intensity and character of activity"? This claim is patently false, and you all, as civil servants in this wonderful city, surely recognize that. Why do you continue to proceed as if this were true?
- 3. Moreover, this center is not a place "of similar activity" as the church that formerly operated on the property, as the petitioner claimed on the Special Exception Use permit. Really? You consider that a

10,000 square foot childcare center licensed for up to 130 children, full-time, five days a week can be construed as "similar" to the small church it replaces? This is another patently false statement. The church operated only on Sunday mornings. Even in the past, when there was a small preschool on the site--and some of us in the neighborhood happily sent our children there--the drop-off hours were well after Clague's drop-off had cleared. This hastily put together "Special Exception Use" permit must be denied

- 4. The AAPS did not previously support access to and from this site via Clague Street, which is essentially a school driveway. Clague is growing, and will continue to grow, as will the other nearby excellent schools, Thurston and Logan. You show little concern for what AAPS thinks with regard to shared use of the driveway and their opposition to sharing the easement. Clearly, Rainbow does not care, and again, is this the kind of business that will benefit the northeast area AAPS "campus"? Why are you choosing them over AAPS?
- 5. The petitioner also intends that Clague Street "should act as a stacking area for traffic entering onto Nixon Road minimizing traffic back-up." This is ludicrous. It already is a hazardous "stacking area." Adding 90 more cars is adding danger. And no one yet knows the effects of the three new housing developments currently under construction to our north. This is simply the wrong time for constructing a commercial business in the heart of a growing residential district. Rainbow has thrived in its other locations on thoroughfares in business zones. This little corner is not the place for this type of childcare center.

Should this proposed center go through, and shame on all of you if it does, may this letter serve as Exhibit A in the lawsuit that will certainly ensue when a child is hit or worse as a result of this ill-advised, proposed Center. You were duly warned. Do we really need another traffic-related death of a student near an AAPS facility to show you that this proposal is wrong?

With all due respect, and thanks to you for your tireless work on behalf of the city, I hope you will send Rainbow off to find a better location.
