1. Thomas Partridge - Council resolutions need to be amended and/or re-written to ensure greater resident access to affordable housing, public transportation, healthcare and education on a regional basis. (C-1, DS-1, DS-14 and DS-15)

Thomas Partridge, Scio Township, spoke about the need to support non-profit organizations, including the Center for Independent Living and local senior centers. He urged Council to amend resolutions regarding housing, healthcare and transportation to ensure accessibility for all.

2. Bruce Thomson - A2D2 Zoning (C-1)

Bruce Thomson, a landowner on Huron Street, spoke in support of the D-1 zoning for Huron Street, noting it is consistent with the existing zoning.

3. Gerold Lax - A2D2 Zoning (C-1)

Jerold Lax, 201 S. Division, spoke in support of the proposed zoning for Huron Street. He stated he represents a landowner on Huron Street, noting that the property has always been zoned C2AR and D-1 is appropriate under A2D2.

4. John Etter - Huron Street (C-1)

John Etter, an attorney, spoke about the proposed rezoning of Huron Street. He noted that the letter provided from the Michigan Department of Transportation was addressed to him. Mr. Etter stated he was surprised to hear that MDOT had not previously been notified about zoning changes along this State trunkline. He urged the Council to pursue a D-2 zoning rather than D-1.

5. Robert Snyder - DC-1 and DC-5

Robert Snyder expressed concern about last minute changes to any zoning ordinances and downtown plan amendments without consulting with neighborhoods and citizen advisory groups. Mr. Snyder noted that these advisory groups have worked on these policies for many years.

6. Hatim Elhady - DC-1

Hatim Elhady, 824 Brown Street Apt. 4, questioned the City's priorities on projects when the Stadium Boulevard bridge is failing. He also expressed concern about the City's failing streets and the change in priority from Council regarding the Library lot.

7. Alan Huber - Library Lot Parking (DC-1)

Alan Huber spoke about the vision of the City of Ann Arbor and the future of the Library lot site. He asked that Council preserve this land for the children of the future.

8. Margaret Wong - DC-6

Margaret Wong, 418 S. First Street, a member of Friends of the Allen Creek Greenway, spoke in support of DC-6 as a first step in creating a greenway along the Allen's Creek.

9. Rita Mitchell - DC-6

Rita Mitchell, 621 Fifth Street, spoke in support of the creation of the Allen Creek Greenway. Ms. Mitchell stated DC-6 is a first step in creating the greenway.

10. Kathe Wunderlich - Ann Arbor Airport Emergency Landing

Kathe Wunderlich, a Pittsfield Township resident, spoke in opposition of the proposed expansion of the Ann Arbor Airport. She expressed concern about the runway expansion contributing to larger planes taking off over the Stonebridge neighborhood.
