Dear Mayor Taylor and City Council,

As the Superintendent of Ann Arbor Public Schools, I am writing to support the Ann Arbor City Council's thoughtful consideration of the impact upon our children and schools of the ordinances regarding medical marijuana dispensaries. Specifically, I encourage you to carefully consider dispensary locations relative to our schools.

Mayor and Council, I know you share the critical priority of student safety and wellbeing. Our community values its neighborhood schools and the importance of ensuring that areas near our schools remain safe and supportive of students within the community.

We understand that the City Council is scheduled to vote on whether or not to expand the 1000-foot buffer zone to include daycare and youth centers on Tuesday, September 4, 2018. I would like to add support to the amendments involving the location of the dispensaries:

1. To increase the minimum distance between marijuana dispensaries from the current 600 feet to 1000 feet.

2. To expand the 1000-foot buffer zone between schools and marijuana dispensaries/facilities to include childcare centers, childcare homes and youth centers.

3. To give consideration to protecting other vulnerable populations including those in substance use disorder services or programs.

Ann Arbor's schools are strategically situated in safe neighborhoods and we support all efforts to maintain them as such. As educators whose responsibilities include the protection of our community's children in and around our buildings, we want to encourage you, as you work through these decisions, to keep the safety of our children at the forefront.

I urge you to include the expertise readily available within our own community and engage all impacted stakeholders in the formation of a strategic planning committee around the use of medical marijuana to ensure that all voices are heard. There is no safe amount of marijuana exposure for children and it is our collective responsibility to maintain the safety of our infants, toddlers, gradeschool children and adolescents in Ann Arbor.

the same time.

You absolutely know that there is no connection logically between childcare centers and cannabis dispensaries. No councilmember has even attempted to explain what the logical connection could be.
