#### WATER, SEWER AND STORMWATER RATES

ORDINANCE TO AMEND SECTIONS 2:63 AND 2:64 OF CHAPTER 29 (Water, Sewer and Stormwater Rates) OF TITLE II OF THE CODE OF THE CITY OF ANN ARBOR

The City of Ann Arbor ordains:

<u>Section 1</u>. That Sections 2:63 and 2:64 of Chapter 29 of Title II of the Code of the City of Ann Arbor be amended to read as follows:

### 2:63. - Water rates.

(1) The commodity charges for water service are as follows. The rates shown are per unit, one unit equals 100 cubic feet (1 CCF).

#### 2:64. - Sewer rates.

(1) The Commodity commodity charge for customers in Ann Arbor shall beis \$5.555.19 per 100 cubic feet (CCF) of water flow, of which \$1.321.83 is a user charge for wastewater plant operation, maintenance and replacement, 2648 cents is a user charge for field operation and maintenance of the sewer system, 5749 cents is a user charge for system planning and administration, and \$3.402.93 is applied toward a portion of capital expenditures and debt on prior capital expenditures. Charges for sewer service provided to Ann Arbor Township, Pittsfield Township and Scio Township shall be as provided per the provisions of their respective wastewater treatment or sewer agreements with the City of Ann Arbor.
