### INT-1 09-0749 Revenue Projections

Tom Crawford, CFO, gave a presentation on the City of Ann Arbor revenue projections for FY 2010 and 2011. Mr. Crawford explained that the economic environment in the State of Michigan and the City of Ann Arbor looks grim and that there are serious implications for the City budget. He explained that Council will have little flexibility for obtaining additional revenue and additional cost reductions will likely require reduced City services. A public hearing was conducted on the proposed Application of AVL, Inc. for an Industrial Facilities Exemption Certificate in Industrial Development District No. 2009-030 located at 1801 E. Ellsworth. Notice of public hearing was published July 26, 2009.

Karen Sidney, 100 Longman Lane, said that Council should reconsider the policies relating to exemption certificates, demand accountability from the applicants, and to look at other ways to raise revenue for the City.

Thomas Partridge, 4220 Eyrie Dr., spoke in opposition of the proposed exemption certificate. He recommended that this and all certificates have a return on investment clause included.

There being no further comment, the Mayor declared the hearing closed.

### **COMMUNICATIONS FROM COUNCIL**

### COUNCILMEMBER RAPUNDALO

Councilmember Rapundalo stated that he and Councilmember Derezinski were working with the City Attorney's Office to ban the use of cell phones while driving. The ban would also prevent texting while operating a motor vehicle. Councilmember Rapundalo stated he is hoping to bring the ordinance forward to Council for consideration on August 17 or September 8.

Councilmember Rapundalo responded to a public comment regarding Industrial Facilities Exemption Certificates.

### **COUNCILMEMBER ANGLIN**

Councilmember Anglin informed Council that the Michigan Inn has finally been demolished. He thanked all City staff for their efforts on this project.

### **COUNCILMEMBER HIGGINS**

Councilmember Higgins updated Council regarding the work of the Rules Committee. She stated they are struggling with policy decisions and Council may need to have a Work Session to discuss the Rules in more detail as a group.

Councilmember Higgins reminded the Administration Committee that it is time to do the annual review for the City Attorney and City Administrator.

Councilmember Higgins stated the Budget and Labor Committee has been discussing labor strategies and will be meeting again to discuss negotiations.

### MAYOR HIEFTJE

Mayor Hieftje responded to comments made during public comment regarding only having one person speaking at a time. He stated this allows everyone to speak without fear of interruption or disruption. The rules must be consistently enforced.

Mayor Hieftje responded to a public speaker's comments regarding Industrial Development Districts and abatements. He stated the City does not write a check. Mayor Hieftje noted that if the businesses relocate or do not come to Ann Arbor, the City will not gain any tax increases.
