Will Hathaway, a member of the Ann Arbor Central Park Ballot Committee, spoke in opposition of the proposed resolution instructing the City Attorney how to proceed with the lawsuits regarding Proposal A. He urged the City to move forward and accept the settlement proposals.

A member of the audience asked for clarification if Core Spaces would be discussed in closed session. He urged the Council to settle as the City Charter has been amended and that must be followed.

Peter Nagourney, 914 Lincoln Ave, expressed concern with the current role of the City Attorney in providing advice to the City Council on the Core Spaces project. He urged the City Attorney to support the will of the voters and settle the lawsuits.
