Thank you so much for your very thorough response.

I'd like to speak to just one point, because I think it is a very important one....

The map you enclosed does not differentiate between family housing and single unit low-income housing. In my experience and understanding, there is a very large difference with respect to associated crime with high density. Carrot way is family housing, correct? And Miller Manor is single unit, right?

My understanding is that this neighborhood is saturated when it comes to the number of single-unit low-income housing units, and possibly the most dense in the city. I think that is an important distinction.

Ms. Briere was kind enough to call me over the weekend to discuss these concerns as well. She talked about the pressure from funding sources to create higher density housing, which I understand. But there is density in regards to a building/site, and density or concentration in a neighborhood. And perhaps the latter is more under our control? Our neighborhood has not historically organized itself into a cohesive voice on these issues, and I am hopeful that now we will begin to do so. I just wish we didn't feel so cornered into it. I really do wish we could have looked at this single-unit density issue before approving this project.

Aside from that, I am thrilled to hear there is new management at Miller Manor. And I hope to hear more about that tomorrow night.

Thank you very much for writing and adding your voice to this conversation. Please allow me to speak to some of your concerns.

In regard to the crime that has popped up in your area; the AAPD is hard at work investigating and dealing with these problems. They are fully committed to this effort as we all are and they will soon have a good handle on the situation.

I am aware of the number of affordable units in different neighborhoods and have consulted with staff on this point. After studying this map it appears that in comparison to several other areas of the city there is not a concentration of designated affordable or supportive housing in the area North of Miller and West of Main. If you have information that indicates otherwise please pass it along.

You mention Burns Park. From my life long experience in Ann Arbor including nearly 20 years in residential real estate (something I gave up shortly after becoming mayor) the reason this area has not been utilized for affordable housing has much more to do with land values than any perceived "clout." Houses sell for more in part because when homes that would otherwise be ideal for conversion to affordable housing go on the market they are snapped up by landlords for use as student rentals. Investors can move much faster and bring more cash to the table than affordable housing providers. This helps to keep the prices high. The high concentration of students who often do not lock their doors leads to a fair amount of crime in the area.

The available studies do not indicate that supportive housing creates problems in neighborhoods but we are looking for other studies that would shed further light on this question.

In the case of Miller Manor; the City recognized there was a problem some time back and began an investigation over a year ago. New management was put in place in August. This should begin to make a difference soon and senior city staff are watching this closely.

I should also point out that Miller Manor is not supportive housing but rather federally funded low income housing.

In the Near North proposal there are 14 units that will be managed by Avalon but the rest of the units are priced for working singles and couples. One of the complaints we have heard repeatedly over the past several months we have been talking about this has been that rents for the 25 units are too high, at or near market rate, even though they technically qualify as "affordable" for those making 50% of the median income.

There is synergy to be gained by having the 14 units in one location given that the supervision and oversight can be tighter. I would point to Carrot Way off Dhu Varren Rd. This complex of 30 affordable units is managed by Avalon and is often held up as a model community.

In my experience in the city Avalon has an excellent reputation for management. In nearly 10 years of public service I have heard very few complaints about Avalon owned housing.

There was a recent reduction at the PD but it did not impact the number of officers patrolling your neighborhood (the same number of officers is on patrol in the city as before) and there is an intense focus on solving the problems that have cropped up in recent months. A very few perpetrators; two or four, can be the cause of a large number of breaking and entering cases and it is only a matter of time before they are caught or driven from the area by increased pressure.

I have included a map of the affordable housing in the city. Please take a look at the distribution.

Over the many months that Near North has been before the city it has evolved from a larger proposal that was rejected by the nearby neighborhood association into something they can accept.

Hello Mayor and Council members.

Some of you know, and perhaps some of you do not, that the Sunset/Brooks/Summit neighborhood has been hit with a major increase in break-ins, with something like 19 break-ins since May. My home was one of the ones hit. We recently had a neighborhood meeting held by one of the police lieutenants regarding the increase in crime that we are seeing in our area. Attendance at this meeting was very large, and an email list was generated from that meeting, as a sort of neighborhood watch.

I have been deeply concerned about was seems to be a saturation of low-income housing in our neighborhood, with Miller Manor being the most obvious and aggregious example of this. This crime spree magnifies my concern. I am getting to the point where I do not want to let my kids walk to school or to our local park (Hunt) by themselves. This is unacceptable to me.

I have heard, through this neighborhood list, that there are many of us very concerned about the uptick in crime in our area, even before these break-ins.

I assume that you all know that low-income housing works best when done in low-density distribution. Low density both in terms of the site/building itself, as well as the neighborhood density. I hope that you all know this! It's considered Best Practices, and I hope that as people in charge of deciding on these projects, you would know this.

I would like to ask you all if you have looked at the crime reports coming out of Miller Manor? If not, I would like to request that you please do so before Monday's vote. This is another thing I would expect you to know before making this decision. Miller Manor is a disaster. Miller Manor, as I understand it, has 105 one-bedroom units. Near North will have 39 more one-bedroom units. We are not talking about family housing here. Please take


a moment to look at the rest of the single-person supportive housing we have in our area... I can think of 6-7 Avalon houses (maybe more), the shelter, several properties owned by Dawn Farms, the Ozone house, 701 Miller, Miller Manor.... and now you want to add more? My research tells me we have over 200 of these units in about a 5 square-block area! Where did Best Practices go???

We are not a sacrificial neighborhood, just because we don't have the wealth and clout of a Burns Park. Affordability does not automatically mean we will continue to be a quiet, compliant dumping ground for all the single-unit supportive housing you can fit in here. I am extremely concerned that in the face of all this increased crime in our neighborhood, and all this density, and cuts in numbers of police officers, and cuts in support services that include those that support public housing, that you actually know all of this, and yet think that putting more of this in our neighborhood is a good idea for this city.

For the council members that do not represent our wards.... please consider the fact that you DO represent our city. And just because this is not happening in your neighborhood does not mean that it's not a BAD idea to concentrate this much density in one small area! We are saturated here.

We will be meeting as a neighborhood on Tuesday night to discuss these issues. This meeting had to be rescheduled from Saturday due to Rosh Hashanna. It is extremely unfortunate that our meeting will be a day after you vote on Near North. I am asking you to please, please take a step back from this project and look at the bigger picture. The research is clear on density, and this is a bad idea.

Above and beyond Near North, we will be discussing Miller Manor at our meeting. The management of this city-owned property is abysmal. We want something to be done about it. And we no longer wish to be considered the sacrificial neighborhood in future housing decisions.



RESOLUTION OPPOSING 2010 STATE OF MICHIGAN BUDGET PROPOSED BY HOUSE SPEAKER ANDY DILLON AND SENATE REPUBLICANS

WHEREAS, Democratic House Speaker Andy Dillon has tentatively agreed to a State of Michigan Budget proposal for fiscal year 2010 that was developed by Republican leaders of the Michigan Senate;

WHEREAS, the proposed Dillon-Republican Budget would slash statutory revenue sharing to Michigan municipalities by 30%;

WHEREAS, the proposed Dillon-Republican Budget would result in a dramatic reduction in statutory revenue sharing for the City of Ann Arbor in the amount of approximately \$1,200,000 per year;

WHEREAS, the drastic cuts to statutory revenue sharing proposed in the Dillon-Republican Budget would have devastating consequences on Michigan municipalities – including the City of Ann Arbor – by forcing reductions in spending for vital public services, including police protection, fire protection, park operations, and human services;

WHEREAS, the State of Michigan has already slashed statutory revenue sharing to Michigan municipalities by millions of dollars in recent years;

THEREFORE, BE IT RESOLVED, that the Ann Arbor City Council opposes the State of Michigan budget for fiscal year 2010 proposed by House Speaker Andy Dillon and Senate Republicans;

BE IT FURTHER RESOLVED, that the Ann Arbor City Council urges Senator Liz Brater, Representative Pam Byrnes, and Representative Rebekah Warren to vote against the State of Michigan budget for fiscal year 2010 proposed by House Speaker Andy Dillon and Senate Republicans;

BE IT FURTHER RESOLVED, that the Ann Arbor City Council urges Governor Jennifer Granholm to veto any proposal to cut statutory revenue sharing to Michigan municipalities;

BE IT FURTHER RESOLVED, that the City Administrator shall provide a copy of this resolution to Governor Granholm, Senator Brater, Representative Byrnes, Representative Warren, and the president of all local unions representing City of Ann Arbor employees; and

BE IT FURTHER RESOLVED, that the Ann Arbor City Council urges Senator Brater, Representative Byrnes, and Representative Warren to provide the City Council with a written summary of their position on the Dillon-Republican budget proposal.

DC-2 Substitute Resolution

Resolution to Disclose Council Electronic Communications without Charge to the Public

Whereas, on September 8, 2009, City Council amended its rules to place limitations on electronic communications during Council meetings, and the routine disclosure of such communications in the future will help the public monitor compliance with the amended rules; and

Whereas, it is in the public interest to disclose all electronic communications to and/or from Council members during Council meetings for; and

Whereas, many members of the community want to view these electronic communications and rapid disclosure of all the electronic communications will help restore public confidence in City Government; and

Whereas, the disclosure of such communications should be done in an orderly way so as to minimize staff time and costs; and

Whereas, it is more cost-effective that the disclosure of such communications be done systematically, rather than in response to Freedom of Information Act requests that may be made by the public in the future;

RESOLVED, that, going forward and beginning with the Council meeting of September 21, 2009, the City Clerk shall append copies of all electronic communications defined as public records under the Freedom of Information Act sent to and/or from members of Council during a City Council meeting, with deletions authorized by that Act, to the official minutes of that meeting when published on the City's website.

RESOLVED. That City Council directs the City Administrator to provide an explanation of the basis under the Michigan Freedom of Information Act or other statute for the determination that the electronic communication or a portion thereof, is exempt from disclosure, including the statutory provision authorizing the withholding information from the public. If the City Administrator determines that the contents of an electronic communication, in whole or in part, is subject to a disclosure exemption under the Act, the email, including the header information, will be included in the materials disclosed with the exempt portions redacted.

RESOLVED, that by December 1, 2009, the City shall post on its website copies of all electronic communications to and/or from Council members during Council meetings, with deletions authorized by that Act, from January 1, 2008 to this date that have not already been disclosed as above.

Deleted: RESOLVED, that by January 1, 2010, the City shall post on its website copies of all electronic communications to and/or from Council members during Council meetings, with deletions authorized by that Act, from January 1, 2007 through December 31, 2007 that have not already been disclosed as above. ¶

RESOLVED, that by the first day of each succeeding month, the same procedure shall be followed for each prior calendar year of such electronic communications until all such communications have been disclosed.
