The Michigan Public Service Commission (Commission) will hold a pre-hearing to consider DTE Electric Company's (DTE Electric) May 30, 2019 application for reconciliation of its 2017-2018 Demand Response (DR) program costs. DTE Electric requests that the Michigan Public Service Commission: 1) approve DTE Electric's 2017 and 2018 DR reconciliation in the amounts of \$2,190,647 million in capital expenditures above the originally authorized levels in prior general rate cases and \$373,380 in Operation & Maintenance (O&M) expenses above the authorized levels in Case U-18255; 2) approve that the actual additional capital expenditures will be deferred as a regulatory asset if the Commission declines to include the costs as plant in a 2019 DTE Electric general rate case filing; 3) confirm deferred regulatory asset treatment is available for additional operating costs and capital expenditures that are reconciled in future annual reconciliation cases, regardless of whether regulatory asset treatment is ordered in the instant case; 4) approve a defined financial incentive structure for DTE Electric's future investment in the DR portfolio subject to future reconciliation cases resulting from a proposal of a joint work group including the Commission's staff.
