Councilmember Lumm suggest to designate a community liaison in Section 1:217 - Same -Community relations. Have the City Attorney walk us through the procedures (at another meeting).

Chair Stephens discussed next meeting complaint procedures- all complaints available for upcoming meetings starting from April 30, 2019. Acting Chief Forsberg discussed giving the department adequate notice to prepare any re-occuring information to review at ICPOC meetings.
