## AMENDMENT NUMBER 1 TO AGREEMENT BETWEEN DOMESTIC VIOLENCE PROJECT AND THE CITY OF ANN ARBOR FOR CONFIDENTIAL VICTIM SUPPORT SERVICES

This Amendment Number 1 ("Amendment") is to the agreement between the City of Ann Arbor ("City"), on behalf of the 15th Judicial District Court, and the Domestic Violence Project, Inc., a.k.a. SafeHouse Center (the "Contractor"), for Confidential Victim Support Services, which is dated April 3, 2017 ("Agreement"). City and Contractor agree to amend the Agreement as follows:

1) Article I – Scope of Services/Compensation is amended to read as follows:

The Contractor will: provide confidential support, information and referrals for victims of domestic violence and intimate stalking cases in the 15th Judicial District Court, 14A Judicial District Court and 14B Judicial District Court; monitor court and probation activity as it relates to victim safety; work collaboratively to enhance victim safety; and offer advice and training to judges, magistrates, probation officers, and community partners.

Services provided by the Contractor pursuant to this contract are funded via an Office on Violence Against Women of the US Department of Justice Grant Award 2016-WE-AX-0031, awarded to the 15th Judicial District Court and accepted on behalf of the Court by the City of Ann Arbor Council.

Upon completion of the above services and submission of invoices via the 15th Judicial District Court, the City will pay to the Contractor an amount not to exceed One Hundred Forty Five Thousand One Hundred Ninety Seven Dollars and Fifty Nine Cents (\$145,197.59) for the period of October 1, 2016 through September 30, 2020 inclusive or, in the event the grant term is extended to any date beyond September 30, 2020 by the US Department of Justice, in that case the period eligible for payment to the Contractor by the City shall be extended to a date concurrent with the extended grant termination date.

The parties acknowledge and agree that reimbursement required by this agreement is subject to the availability of grant funding through from the Office on Violence Against Women of the U.S. Department of Justice.

2) **Article III - Term** is amended to read as follows:

<u>Section</u> 1 - This contract begins on October 1, 2016 and ends on September 30, 2020.

<u>Section 2</u> – In the event the US Department of Justice extends the term of the grant to any date beyond September 30, 2020, in that case the term of this agreement shall be extended to a date concurrent with the extended grant termination date without further action by the parties.

All terms, conditions, and provisions of the Agreement, unless specifically amended above, shall apply to this Amendment and are made a part of this Amendment as though expressly rewritten, incorporated, and included herein.

City and Contractor agree that for this Amendment and any documents related to the Agreement: 1) signatures may be delivered electronically in lieu of an original signature; 2) to treat electronic signatures as original signatures that bind them; and 3) signatures may be executed and delivered by facsimile and upon such delivery, the facsimile signature will be deemed to have the same effect as if the original signature had been delivered to the other party.

This Amendment to the Agreement shall be binding on the Parties' heirs, successors, and assigns.
