Thomas Partridge, Scio Township resident, said that housing development is critical to the economic development of Ann Arbor and the region. He added that larger appropriations and grants for affordable housing are needed.

2. John Lofy - Decision to Repair Argo Dam (CA-3)

Not present.

3. Kathy Griswold - Student Safety (DC-3)

Kathy Griswold, 3565 Fox Hunt Drive, addressed Council regarding student safety. She stated she is concerned that the City has a campaign to increase the number of cyclists and walkers, but is doing nothing regarding safety.

4. Kevin Bolon - Recycling (DS-3)

Kevin Bolon, 1924 Lindsay Lane, spoke in opposition of the proposed recycling program. He urged Council to reject the idea of single stream recycling and use the recycle bank proposal with the current two-stream system.

5. Alan Haber - Project Budget for South Fifth Avenue Underground Parking Structure (DS-11)

Alan Haber, 531 Third Street, addressed Council regarding the project budget for the South Fifth Avenue Underground Parking Structure. He said the Ann Arbor Committee for the Commons is having a meeting next Sunday at 310 S. Ashley at 3:30 p.m. to continue to invite public input into the proposal for a common space at this site.

6. Seth Best - Contract with the Shelter Association of Washtenaw County (DC-1)

Seth Best, 312 W. Huron, spoke in support of the proposed resolution for emergency funding for the Shelter Association of Washtenaw County. Mr. Best stated he used the center last year and understands the great need for funding at the Delonis Center.

7. Brian Nord - Contract with the Shelter Association of Washtenaw County (DC-1)

Brian Nord, 508 Krause Street, spoke in support of the proposed contract with the Shelter Association of Washtenaw County.

8. Libby Hunter - Recycling (DS-3) & Project Budget for South Fifth Avenue Underground Parking Structure (DS-11)

Libby Hunter, 827 Bruce, addressed Council in song regarding her opposition to single stream recycling and the project budget for the South Fifth Avenue underground parking structure.

9. Kermit Schlansker - City Responsibilities

Kermit Schlansker, 2960 Marshall Street, addressed Council regarding the City's responsibilities towards global warming and tree planting.

Councilmember Hohnke recommended the reappointment of Christopher Graham to the Environmental Commission for consideration at the 11/16/09 Council meeting.

He added that the Environmental Commission reviewed and supported a change to the City Code that came out of the Malletts Creek Coordinating Committee to try to control stormwater runoff in the first flush on single and two-family residential properties, when homeowners are adding 200 sq. ft. or more of impervious surface. A public hearing on this matter is scheduled for November 19, 2009 at 7:00 p.m. in the Council Chamber.

COUNCILMEMBER BRIERE

Councilmember Briere said that she attended the second meeting of the Washtenaw County Land Bank Authority. Ms. Briere expects to have all members appointed to this board by the third meeting in November, which is scheduled for November 30, 2009. They also plan to adopt by-laws at that meeting and begin work.

COUNCILMEMBER ANGLIN

Councilmember Anglin announced that on November 14, 2009, at 9:15 a.m., there will be a tree planting in the Virginia Park Neighborhood.
