## Motion 1

AAPAC recommends to City Council to accept the proposal by Herbert Dreiseitl for the outdoor public art installation to be sited at the Municipal Center and approve the budget and contract amendment with Quinn Evans Architecture, as stated in the budget of 10/16/09. AAPAC further recommends that, upon receiving more detailed budgets for lighting costs and water technologies, these budgets be reviewed for potential savings.

**VOTE:** Motion was passed unanimously.

#### Motion 2

AAPAC recommends to City Council to accept the proposal by Herbert Dreiseitl for the watershed etching and installation to be sited at the Courts/Police building of the Municipal Center and approve the budget and contract amendment with Quinn Evans Architecture, as stated in the budget of 10/16/09. This approval is contingent upon reaching a satisfactory lighting solution before fabrication of the lights for the installation.
