#### VI OLD BUSINESS

### a HB-4738 CROSSWALK LAW

- Z. Damon asked commissioners for any feedback regarding the law. T. Hull discussed the issues that he has identified with the law and the standards it would set. The Transportation Commission will be looking to make recommendations during the meeting later that evening. E. Nelson also discussed a consultant that is coming to the City who could potentially review the state of the City's crosswalks and provide advice.
- Z. Damon will be forwarding the crash data by next meeting so the commission can assess and break it down for direction moving forward. T. Hull suggests identifying flaws in the local and state laws and putting together an informed statement. As such, Z. Damon asks commissioners to review the local ordinance as well.

### d CHAIR REPORT - ZACH DAMON

Z. Damon gave the chair report. He discussed commissioner attendance, the bylaw and gave his opinion of the commission moving in a direction where they can hold a discussion with commissioners not adhering to the attendance requirements in the bylaws. It could then be determined if they would be able to be more present or if the commission should move in the direction of a replacement or resignation. M. Solomon suggests proceeding forward with an initial inquiry to obtain more information, with Z. Damon to reach out to those commissioners to discuss with them in this fashion.

He also discussed a survey from former commission member Amy Shephard regarding mid-section crosswalks, which will be forwarded to commissioners to complete and provide feedback.
