Deanna Relyea, 451 S. Fourth Avenue, expressed concerns about increasing meter enforcement times to 10 p.m. She stated this will make it difficult for patrons of the Kerrytown Concert House to locate parking in the evening.

## 9. Kevin Sharp - Parking Meters (DC-1)

Kevin Sharp, 20433 Bethel Church Road in Manchester, asked Council to reconsider the resolution to extend the meters from 6-10 p.m. He expressed concerns about the ability of the People's Food Co-op to survive with evening meter enforcement.

Alan Haber, 531 Third Street, addressed Council regarding the DDA Minutes of November 4, 2009. He said that he was misquoted in the minutes and he would like the minutes to be corrected.

#### **COMMUNICATIONS FROM COUNCIL**

#### COUNCILMEMBER RAPUNDALO

Councilmember Rapundalo updated Council on the status of the Library Lot RFPs. He stated two proposals had been dropped from consideration after the technical review team determined that they were not qualified. Interviews of the remaining applicants will take place on January 18 with an evening open house for the public. An RFQ is being developed to find an outside consultant to assist with the interview process.

#### COUNCILMEMBER TAYLOR

Councilmember Taylor provided an update on the Park Advisory Commission and their efforts regarding ballfield maintenance and the arrangements with the Ann Arbor Public Schools and Rec and Ed. Councilmember Taylor stated PAC is also looking at the possibility of allowing football Saturday parking at Frisinger and Allmendinger Parks. In concept, PAC is supportive. Councilmember Taylor also stated an arrangement has been made with Pittsfield Village regarding snow removal.

#### COUNCILMEMBER DEREZINSKI

Councilmember Derezinski stated he is working on a committee studying the Washtenaw Avenue corridor. The committee includes representatives from Ypsilanti and Ypsilanti Township, as well as Pittsfield Township and the City of Ann Arbor.

#### **COUNCILMEMBER ANGLIN**

Councilmember Anglin stated he was disappointed to learn that two proposals were dropped from the Library Lot RFP process. He stated the intent was for the public to get an opportunity to review all proposals.

Councilmember Rapundalo responded to Councilmember Anglin's comments, noting that the RFP was very clear in that the proposal had to provide a financial incentive for the City. He stated two projects were dropped from consideration because they did not provide a financial benefit to the City.

## COUNCILMEMBER HOHNKE

Councilmember Hohnke noted that Wednesday marked the 35th anniversary of W.A.T.S. (Washtenaw Area Transportation Study). Councilmember Hohnke also updated Council on the Mack Pool Taskforce, noting that the committee reported to the public on December 10 regarding its progress.

#### COUNCILMEMBER SMITH

Councilmember Smith informed the public that a revised version of her proposed Resolution Regarding Parking Meters was available in paper copies at tonight's meeting.

#### **COMMUNICATIONS FROM THE CITY ADMINISTRATOR**

#### CITY HALL ELEVATORS

City Administrator Roger Fraser announced that the City Hall elevators were not working before 7 p.m. He advised that the north elevator may not be available following the end of the meeting, but the public should be able to utilize the south elevator when exiting the building.

#### **BUDGET WORK SESSIONS**

Mr. Fraser stated that Council received information from him summarizing the discussion of the December 5 Council Retreat / Work Session. He stated a Work Session has been scheduled for January 25 to allow staff the opportunity to present their findings regarding the potential cuts proposed. A January 12 staff meeting for all employees has also been scheduled to allow the administrators to update staff on the state of the current budget.

#### STADIUM BRIDGES PROJECT

Mr. Fraser announced that he and City staff have been working closely with Congressman Dingell's office and State Representative Warren, but have been unsuccessful in securing federal funding for the Stadium Bridges project.

#### PUBLIC SERVICES AREA

Mr. Fraser updated Council on activities in the Public Services Area, including that a goal of 1000 trees planted this year had been set. Mr. Fraser noted that at the half-way mark of the fiscal year, the City has already planted over 700 trees.

Mr. Fraser stated a study has been completed on the Argo Dam impoundment and the study concluded that there is no immediate threat or concern.
