Safety Notes

A2 Be Safe! Coronavirus (COVID-19) update. City of Ann Arbor Emergency Management personnel are in active collaboration with the Washtenaw County Health Department, local hospitals, the University of Michigan, and the American Red Cross for the coronavirus outbreak. It's important to note that the Washtenaw County Health Department is the lead agency as they have emergency operations plans to address infectious disease and pandemics.

The city will continue to monitor this rapidly evolving situation and coordinate closely with its local partners, including Washtenaw County Health Department, to determine if this closure date should be expanded. - Wash your hands often with soap and water or use hand sanitizer.
- Avoid touching your eyes, nose, or mouth with unwashed hands.
- Cover your mouth and nose with a tissue when coughing or sneezing.
- Avoid handshakes.
- Avoid contact with sick people who are sick.
- Stay home when you are sick.
- Per the State of Michigan's "Stay Home, Stay Safe" executive order, City of Ann Arbor nonessential operations and all city buildings are closed through Thursday, May 28. These measures will not impact critical services such as drinking water, waste water, police, fire, emergency operations and waste and recycling pickup.
- While city buildings remain closed through at least May 28, following the governor's recent extension of the State of Michigan Stay Home Stay Safe Executive Order, the city's executive team continues to meet regularly to address COVID-19-related issues and ensure essential services continue to be delivered. Discussions are starting for plans for the eventual re-opening of city buildings and services at some future date. All of these discussions include a focus on employee safety as well as ensuring physical distancing practices can be continued.

Enforcement

Following the announcement of the governor's "Stay Home, Stay Safe" executive order, law enforcement agencies have received many questions related to how citizens can report a business or individual that is violating the order. Originally, the public was directed to the attorney general's office. However, due to the overwhelming response, local law enforcement agencies are asking residents to report complaints directly by contacting 9-1-1.

While all aspects of the executive order are to be followed and law enforcement will respond appropriately to reported violations, callers are being asked to report only those behaviors that pose a credible and serious risk to public safety and that may exacerbate community spread.

- Public safety leaders from each agency within Washtenaw County, including the Ann Arbor Police Department, have aligned response protocols to include the following: Upon calling 9-1-1, dispatch will relay the complaint to local police agency.
- Each agency will determine the severity of the violation and respond appropriately.
- Initial response will focus on education in order to gain compliance with the order.
- The intent is not to arrest, but enforcement action will be taken as deemed appropriate.

Allen Creek Berm Project. Kudos to everyone involved in the Allen Creek Berm Project. Particularly, city engineer Nick Hutchinson, construction phase project manager Brian Slizewski, design phase project manager Anne Warrow, consulting teams from Bergmann & Associates (design phase), and Fishbeck (construction phase) all worked to make progress.

The railroad tracks were removed on Tuesday, May 12th, the culverts were placed, and the tracks were back in operation late Wednesday, May 13th. Many actions still need to happen before this project is completed and open to the public, but this was a "big lift" for the project.

 Title II of the Code of the City of Ann Arbor. Approval of this ordinance would increase sewer
 rates due to the continuing need to recover revenues required for the purposes of debt

 20% of the collection system.
- A public hearing and An Ordinance to Amend Section 2:63 of Chapter 29 (Water Rates) of
 Title II of the Code of the City of Ann Arbor. Approval of this ordinance would increase water
 rates for upcoming operating and capital infrastructure investment needs. Rates will help
 finance the increasing operational costs and increased costs associated with regulation of the
 water supply system.
- A public hearing and An Ordinance to Amend Section 2:69 of Chapter 29 (Stormwater Rates)
 of Title II of the Code of the City of Ann Arbor. Approval of this will help finance the
 completion of the four-year phased roll in of the level of service increases which began in
 2017.

 A public hearing and An Ordinance to Amend Section 9:42 of Chapter 107 (Animals) of the Code of the City of Ann Arbor. Approval of this ordinance would remove the procedural step of neighbor notification.

FY21 Budget Resolution

 Resolution to Adopt Ann Arbor City Budget and Related Property Tax Millage Rates for Fiscal Year 2021. In accordance with City Charter, City Council, with at least seven affirmative votes, must adopt the budget no later than the second meeting in May (May 18). This Monday, May 18th City Council will be meet virtually taking into consideration all of the proposed budget recommendations. Curbside Compost Collection Began April 6 with Carts Only Until Further Notice. The City of Ann Arbor 2020 curbside compost collection program began, as scheduled, on Monday, April 6. However, to ensure the safety of staff and protect them against the possibility of COVID-19 exposure, yard waste bags and bundled brush/limbs will not be serviced at this time. Collection will be done only from carts, using the mechanical arm on solid waste vehicles. To clarify, residents will only be able to use curbside compost service to discard their compost if the materials are placed into their compost carts.

The city is requesting that residents and property owners who may have already loaded and placed yard waste bags at the curb, remove those bags and store them in a dry location until full service can be restored. In addition, be advised that the city's compost facility is closed to all residential and contractor drop-off and compost pick-up operations until further notice.

The city understands this change in service will be inconvenient and very much appreciates the community's help in keeping city staff safe and healthy. The city is offering a compost cart, 64 or 96 gallon size, to any home that doesn't currently have one for a delivery fee of \$59. Orders for additional carts will be charged the additional cart fee. Please note that repeat orders will be placed behind first-time orders.

Ann Arbor 2020 Planned Road, Utility & Resurfacing Projects. The City of Ann Arbor is planning for a significant 2020 construction season with nearly 10 miles of resurfacing/restoration projects, some with utility improvements included, as well as 9 miles of capital preventative maintenance work. Due to Michigan's response to the COVID-19 pandemic, a timetable for when these projects will begin and conclude is not yet available. All projects are listed online at www.a2gov.org/roadconstruction.

Construction work will cause road and lane closures, so travelers are advised to sign up for email or text alerts, at www.a2gov.org/roads.

2020 Ramp and Sidewalk Repair Program. The City of Ann Arbor's Sidewalk Repair program is underway. In order to take advantage of reduced pedestrian and vehicular traffic volumes as a result of the pandemic, the schedule has been shifted so that work began in the downtown area. Doing this area first will allow for quicker construction and will limit the impact on businesses, many of which are still closed. Work is scheduled to be completed in this area in June.

The 2020 ramp and sidewalk repair program will begin in the Spring, and will continue into the Fall in the 2020 areas highlighted on the map. More information is available: a link to the website: www.a2gov.org/sidewalks

County-Wide Road and Non-Motorized Millage Education Resources. This is the start of Washtenaw County Road Commission communication efforts to educate the public about the <u>current road and non-motorized millage</u> and what could be accomplished if the millage is renewed by voters on August 4. Resources discussed at the May 14th meeting include <u>meeting</u> slides and the meeting recording.

City of Ann Arbor Launches Online Access to Planning and Building Records and Permits. The public can now go online to view and download City of Ann Arbor plans and permits that the building and planning departments have stored over the years. Documentation from as far back as 1930 up to 2007 that was previously only available as microfilm, microfiche and paper documents, can now be found in PDF format linked at www.a2gov.org/departments/build-rent-inspect/building/Pages/default.aspx. Smaller, letter-sized permits as well as blueprint-sized plans are available online. Records from 2008 to present have already been available online via the city's eTRAKiT system at https://etrakit.a2gov.org/etrakit3/.

"Efforts to bring these older records and documents online started one year ago," said Community Services Area Administrator Derek Delacourt. "Access to the public is more convenient now, and the original aging media is also preserved."

These documents, previously only available upon request, are useful to the public for several reasons. They show current owners, real estate professionals or prospective buyers past construction information on a house or building; provide statistical data to researchers; and document past work for contractors to review before starting new work on a site.

City Provides Updates on Building Inspections, Plan Review and Permit Processing. The City of Ann Arbor is providing updates on operations involving construction plan review, permits and inspections amid the State of Michigan Stay Home, Stay Safe Executive Order.

Plan review and permit submission:

 In accordance with the state executive order, permit applications and plans for review will continue with digital submission via email (up to 150MB) using the <u>building@a2gov.org</u> email address.

- At this time, expedited plan reviews have been suspended until further notice. The city
 will actively assess the demand for this service and, when the state stay-home executive
 order is lifted, will determine when conditions will allow for expedited reviews to
 resume.
- Issued permits and approved plans will be posted online for public access via eTRAKiT at https://etrakit.a2gov.org/etrakit3/.
- Invoices can be paid online. (Click the "pay for" pull-down menu, then click "invoices."
 A service fee will apply). When prompted for a password, please enter your ZIP Code as
 it appears on the invoice. Payment may also be submitted via mail to the city's third
 party payment processing center: Dept #77621, City of Ann Arbor Treasurer, PO Box
 77000, Detroit, MI 48277-0621.

Inspections:

- Onsite inspections for building and trades have continued (as of Monday, May 11).
 Inspections should be requested online through eTRAKIT
 at https://etrakit.a2gov.org/etrakit3/. Inspectors will continue regular communications with the public to discuss their inspection needs and verify timing.
- Inspections for rental properties will resume after the statewide stay-home order has been lifted.
- As a regular protocol for both building and rental inspections, the city will screen all
 inspectors daily for COVID-19 symptoms, inspectors will be equipped with appropriate
 personal protective equipment, and each inspection will be performed adhering to the
 6-foot distancing requirement.
- Alternate means of inspections will remain an option as determined and agreed upon between project leaders and inspectors.

2020 Construction Projects

Allen Creek Berm Opening:

The Allen Creek Berm opening Stormwater and Pedestrian Tunnel project took a huge step forward this week with installation of the three culvert sections under the Wolverine Line railroad tracks. Two of the culverts are stormwater features designed to address the long-standing flooding issue existent in this area. The third tunnel is designed to provide a bicycle and pedestrian, shared-use path, connection linking the north and west downtown neighbors directly with the Border-to-Border trail. This soon to be complete tunnel will provide safe, convenient and legal access to the Argo Cascades for the first time in over one hundred years! Placing the culverts occurred during a scheduled rail service suspension. A time lapse video of this phase of the project is available for public viewing on YouTube; it was captured and posted by W.A.P. John, a long-term resident and local businessman. Work will continue through the spring and summer with construction of the trail to access the tunnel and a bridge over the Allen Creek Outlet, west of the newly placed tunnel. Annual Sidewalk Repair Program:

This program is an annual project to repair sidewalks throughout the City. Further information on the program and a list of 2020 target areas can be found at a2gov.org/Sidewalks. Construction began the last week of April, starting in the downtown area. Work is expected to continue through October.

Annual Street Resurfacing Project:

This suite of projects encompasses the majority of the City's street resurfacing activities, including several major and multiple local streets. Included in the 2020 program are Boardwalk (Eisenhower to north end), Granger (State to Packard), Geddes Ave (Church to Observatory), asphalt path resurfacing on Oakbrook and South Main Street, and a number of residential street resurfacing projects, which will be concentrated in the neighborhood around Dicken Elementary School. A full list of streets is posted on the website at: a2gov.org/RoadConstruction. Construction began May 11, and is expected to continue into November.

Barton Drive (M-14 to Pontiac):

The scope includes street resurfacing, watermain improvements, new sidewalk construction, and intersection reconfiguration at the Chandler intersection. Also included in the project is the reconfiguration of the Barton/Starwick intersection, and the possible filling of sidewalk gaps at this location.

Staff is moving ahead with the proposal to install sidewalk on the north side of Barton Drive from Brede to Pontiac, and at the Barton/Starwick intersection. Resolutions #4 to approve the final special assessment roll for both of these locations were approved by City Council at the May 4 Council meeting. Construction is currently scheduled to start right after Memorial Day.

Huron Street Improvements:

Huron Street sidewalk improvements are substantially complete. The requested transportation and safety enhancement work will be performed by MDOT as follows:

- Leading pedestrian intervals (LPIs) at signalized intersections between First and Division Streets: MDOT initially shared that adequate walk time already existed and noted that adding pedestrian walk time could negatively affect the vehicular operations at the subject intersections. Subsequently, MDOT approved LPIs at the First and Ashley Street intersections with installation as part of the First and Ashley Street Improvements in 2020 and 2021. City/DDA staff will continue to follow up on this request.
- 2. Third and Chapin full signal: Approved. MDOT installation planned for spring 2021.
- 3. Restricted Right Turns: Approved. MDOT installation planned for late summer 2020.
- 4. Permissive/Protected left turn phase at 5th Avenue: Approved. MDOT installation planned for spring 2021.

Jackson Avenue and Washtenaw Avenue Sidewalk Gap Project:

This project includes filling gaps in the sidewalk system on Jackson Avenue (south side) from Westover Avenue to Park Lake Avenue. Also included is the construction of a Non-motorized Path along the south side of Washtenaw Avenue (north of the service drive) from S. Huron Parkway to Pittsfield Boulevard.

Construction is scheduled to begin on the Washtenaw segment of the project in the week of May 18. The cost of the Jackson Ave portion of the project will be specially assessed to the adjacent property owners as it is first-time construction. Resolution #4 to approve the final special assessment roll, as well as the Public Hearing, are scheduled for the May 18 Council meeting.

Other Sidewalk Gap Work

In addition to the sidewalk gap projects referenced above, the following additional locations are planned for 2020, to be done as part of other projects:

- Stimson (both sides) from State Street east part of Sidewalk Repair Program.
 Special Assessment Resolution #2 is anticipated to go to City Council on July 6
- Boardwalk Drive (2875 & 2775), east side part of Resurfacing project. Special Assessment Resolution #2 is anticipated to go to City Council on July 6
- Hollywood Dr. (Maple to Alison), both sides part of Resurfacing project (this work postponed to 2021)

Rectangular Rapid Flashing Beacon (RRFB) Installations:

The following RRFB installations are planned for 2020:

- S. Industrial at Rosewood St. completed January 2020
- S. Industrial at Jewett Ave completed January 2020
- S. Industrial at Central Academy completed January 2020
- S. Industrial at Astor Ave completed December 2019
- Huron Parkway at Glazier Way construction anticipated for early fall 2020
- Huron Parkway at Baxter Rd construction anticipated for early fall 2020
- Note: additional locations may be identified

Projects Currently in Design/Planning

Fuller Court/Nixon/Traver Sidewalk Gap Project:

This project includes the filling of sidewalk gaps on Fuller Ct. (south side) from Fuller Road to 2250 Fuller Ct. and on Nixon/Traver (west/north side) from end of existing sidewalk to Logan Elementary. City Council approved the special assessment rolls for both locations at their May 4th meeting.

At this time, construction is likely going to be delayed until the spring of 2021.

Hollywood Drive (Maple to Allison):

This project consists of the first time paving of a gravel street, which was petitioned by residents in 2017 and subsequently included in the Capital Improvements Plan. The current scope of the project includes paving the street, installation of sidewalks, construction of curb and gutter where necessary, and stormwater improvements consistent with the City's Green Streets policy. An initial public meeting was held on October 2. A second public meeting is scheduled for May 13th at 6:30 p.m. on Zoom. More information can be found on the project website at: a2gov.org/Hollywood. Construction for this project has been postponed until the spring of 2021.

People Friendly Streets Initiative:

First Street construction is scheduled to began May 1, 2020, Ashley Street is scheduled to begin spring 2021.

In December 2019, the DDA Board approved funding for another round of People-Friendly Streets Projects – a collaborative effort with City Engineering. This next round of projects will continue the community conversation about safe, equitable streets in coordination with other on-going efforts, including the City's Transportation Master Plan and Capital Improvement Program (CIP). The DDA is exploring ways to pilot some future improvements as a way to engage the community and help fill a current need for safe access and recreation Design and public engagement are scheduled to begin spring/summer 2020.

Other Updates and Information

ArborBike:

The onset of COVID-19 has complicated the relaunch of ArborBike and the project will not relaunch this year as planned. The pandemic has made the relaunch infeasible in 2020 because: a) the AAATA is experiencing significant budgetary challenges; b) managing and cleaning the system will be difficult with limited personnel; and c) City agreements and permits had not yet been finalized.

Curbside Management Study:

These activities and studies are on hold due to significant impacts to the public parking system fund and significant short-term changes to curbside use. Staff will provide updates as studies and activities resume.

In the meantime, the City and partner agencies are participating in a Transportation for America (T4A) smart cities collaborative on curb management. Ann Arbor is a peer community in this initiative which means it will be part of the conversation, share ideas, help influence, and learn from pilots in Boston, Minneapolis, and Bellevue (WA). "Healthy Streets" - Transportation opportunities for social distancing

Staff shared a memo with the Transportation Commission in April describing some of the considerations of how the public rights-of-way could be used differently to better accommodate social distancing. An updated memo was shared with the Transportation Commission in May. MDOT Coordination:


The City has regular coordination with MDOT on State projects within the City. MDOT allows for local installed improvements on their facilities, subject to their review. In addition to the updates provided above under Huron Street updates, some projects currently being coordinated with MDOT include:

- Huron and Thayer crosswalk MDOT has agreed to an improved pedestrian crossing at this location. The State Historic Preservation Office is reviewing the project which may result in design changes. It is unknown if the improvement will be RRFBs mounted on the side of the road and island, or overhead pedestrian hybrid beacons (aka HAWK). As of now, this project is scheduled for construction in spring 2021.
- North Main Street public engagement for the North Main Street project was scheduled to begin in Spring 2020. However, due to the COVID-19 pandemic, MDOT is unsure if the project schedule can be maintained.

Office of Sustainability and Innovations Update:

City Council passed a <u>resolution in support of creating a plan to achieve Ann Arbor community-wide climate neutrality by 2030</u> at their November 4, 2019 meeting. A
