#### C NEW BUSINESS

Update: Police Oversight during COVID

Chair Jackson discussed some of the webinars she has participated in, including NACOLE; talked about the challenges national oversights are facing during Covid-19. Securing Personal Protection Equipment (PPE), sanitizing hand cuff and contact with the public.

#### Chief Cox updates from the AAPD

Ann Arbor Police Chief Michael Cox discussed his presentation on Policing during Covid-19. He pointed to some of the public health issues such as limited PPD, risk versus reward with personnel, and limited pandemic experience. He emphasized the importance of education, screening for officer and managing expectation. Chief Cox and Assistant Senior City Attorney Arianne Slay discussed domestic violence statistics are up from last year in neighboring counties.

# Trespass discussion

Commission Othman discussed the meeting ICPOC and HRC had on May 6, 2020 on Trespass. In attendance were HRC: Chair, Leslie Stambaugh, Pamela Meadows Dent, Judah Garber and Linda Winkler. ICPOC: Vice-Chair, Frances Todoro, David Santacroce and Jude Walton. Commissioners suggest ways to solve the problem by putting up rules for certain areas and business so the public is aware of what is acceptable i.e., bus terminal. Address social problems; homelessness, and mental health. Make some modification to the trespass notice. Senior City Attorney Arianne Slay had recommended the City issue citations instead of arrest in accordance with the Ann Arbor ordinance. The appeal process provides community resources and wrap-around services.

### Discuss new public forum resolution

Vice-Chair Todoro discussed drafting a resolution to change public comment time to public forum time at ICPOC monthly meetings. This allows the public an opportunity for question and answers time with the commissioners. Finalized draft on the rules for the forum will be presented at next month meeting to review and possibly vote on.
