That in BBA19-001, the appeal for a variance from 2015 Michigan Residential Code Table R302.1(1) for the proposed renovation project at 1213 W. Washington is GRANTED because the Board

finds that maintaining the existing non-conforming opening (window), rather than enlarging it as proposed, results in an exceptional, practical difficulty to the applicant and the owners and and the Board further finds that:

- (a) The performance of the proposed enlarged window will be adequate for its intended use provided that it is a fixed, 60-minute rated glazing assembly and in that regard does not substantially deviate from the performance required by the code for the health, safety and welfare of the people of this state; and,
- (b) The specific condition claimed by the applicant and owners that justifies the variance would be considered neither general nor recurrent in nature.
