*Install new 600A, 480V power panel for installation of (4) 100A circuits for use with new charging stations.

*Transition from the inside of the building to the exterior of the building and run (4) new 100A, 480V dedicated circuits. One to each new car charging station.

*Form and pour (4) new concrete pads in "green Belt" area for use stations.

*Install (4) Charge point car charging stations on new pads
