AMENDMENT NUMBER 2 TO AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN HUBBELL, ROTH & CLARK, INC. AND THE CITY OF ANN ARBOR FOR GENERAL CIVIL ENGINEERING AND SURVEYING SERVICES

The City of Ann Arbor, a Michigan municipal corporation, with offices at 301 E. Huron St. Ann Arbor, Michigan 48107-8647 ("City") and Hubbell, Roth & Clark, Inc. (HRC), having its offices at 555 Hulet Drive, Bloomfield Hills, Michigan 48303-0824 ("Contractor") agree to amend the professional services agreement for General Civil Engineering and Surveying Services executed by the parties dated April 14, 2017 ("Agreement"), as amended by Amendment 1 dated February 12, 2019, as follows:

1) Article V, Paragraph A, Compensation of Contractor, is amended to read as follows:

The Contractor shall be paid on the basis of reasonable time spent and materials used at the rates and prices specified in Exhibit B2 for acceptable work performed and acceptable Deliverables received. The total fee to be paid the Contractor for the Services shall not exceed \$260,000. Payment shall be made monthly following receipt of invoices submitted by the Contractor, and approved by the Contract Administrator.

All terms, conditions, and provisions of the original Agreement between the parties executed April 14, 2017, as amended by Amendment 1 dated February 12, 2019, unless specifically amended above, shall apply to this Amendment and are made a part of this Amendment as though expressly rewritten, incorporated, and included herein.

This Amendment to the Agreement between the parties shall be binding on the heirs, successors, and assigns of the parties.
