**E COMMUNICATIONS FROM THE CITY ATTORNEY**

*Mr. Postema provided written remarks regarding his retirement announcement.*

*Mayor and Council:*

*In 2016, I assured the City Council that I would stay in my position as City Attorney until at least July 2020 and also to provide at least one year notice before resigning or retiring from the position. This was to assure the Council, first, that I would complete a crucial succession planning process for the Office. In specific, over this time I have replaced 5 positions, with 5 attorneys retiring or leaving that had an average of 37 years legal experience and an average of over 16 years of experience with the City. Three of these current replacements were made in 2017, one in 2019, and one in 2020.*

*Because of the importance of succession planning, I also promised at least a year notice on my own plans so that the City Council could plan accordingly. While some wondered whether I would retire in July 2020, relating back to the date made in my earlier promise. I clarified last March in my public statements, I would not be completing my succession planning until the end of 2020. The pandemic arrived, the Council was going to undertake a hiring process for a new City Administrator, and I had not yet finished succession planning, so I did not contemplate providing retirement notice for any time in the near future.*

*However, circumstances have changed recently and I am now providing the City Council with notice of my intent to retire from the position of City Attorney at some point in the year 2022. The exact date is not specific and I will work with the Council Administration Committee on this further. This timing allows the City Council to do a careful plan of succession for my position. In 2022, I will have served the City in this position for nineteen years. And it has been an honor to do so.*

*So there is no confusion about my reason for leaving at this time, my intent is to achieve a more flexible work schedule that allows me to spend more time with family. More specifically, my wife was diagnosed recently with cancer and has been fighting this battle with the excellent care team of the UofM Hospital. We have had to address shorter and longer term implications of her condition and it is clear that I will need to cut back my work commitments in the longer term to address this situation.*

*This time frame also allows time for the City Council to gain its bearing this coming year before undertaking a search process. Further, it allows me time to work with the new City Administrator as he charts a course for the City with the City Council. Finally, the City Attorney's office has many excellent attorneys and staff and this time will further allow them to all work together on behalf of the City before any change is made in this position.*

*I applied for the position eighteen years ago last week. My cover letter included the following introductory sentence: "I would be proud to represent the City of Ann Arbor as its City Attorney." That sentiment remains.*

*As the City Council moves into 2021, which will have many challenges, I hope that the City Council moves forward in a manner that will frame governance in a positive way so as encourage many attorneys to step forward and consider this position and opportunity for public service.*

*I look forward to working with the City Council in this New Year in the important task of taking care of the City.*
