Chief, Roger:

This information is not consistent with the anecdotal data that we have in the Clerk's Office. Just this week, we have received 3 calls regarding bicycle registration. 2 calls were from AAPD and one was from a city resident who found a registered bike, which turned out was stolen from another resident's garage. The resident hadn't even reported the garage break-in because he didn't think anything was missing. We were able to contact the owner about the bike because of the registration information. I don't know whether or not he followed-up and filed a report regarding the break-in.

Most of the calls we receive regarding registrations are from AAPD, but occasionally an out-of-town agency calls us for owner information as well. If I had to guess, I would say we receive maybe 50 calls per year for bicycle registration checks.

I looked at all 39 reports and NONE of them were returned to the owners because of the registration with the city. It was all good police work. On the other hand. I did check and we have 160 found bikes from Sept 2007 to present. I have not gone through those reports. The consensus in property is that less than 15 were returned to the owner because of city registration. If you would like me to read all 160 reports let me know and I can pencil that in for the next couple of weeks. =) Hope this helps.

Resolution calling for the Creation of an Innovative Process of Community Collaboration to Explore a Greenway Park and Arts Center at 415 W. Washington Body

- 1. Whereas, There was a Request for Proposals process for the city owned site at 415 W. Washington that did not result in a proposal moving forward;
- 2. Whereas, In Alternative B of their report, the Greenway Task Force recommended that 415 W. Washington become a combined Greenway Park and Arts Center;
- 3. Whereas, This site is just a short walk from the Main St. area of Downtown Ann Arbor and is just across the street from the YMCA that is enjoyed by thousands of residents including seniors and children;
- 4. Whereas, There is great potential for this site to be the anchor park of a new Greenway that will someday join the existing Huron River Greenway;
- 5. Whereas, The lack of affordable space for studios, art display, and performance space in Ann Arbor is known to have forced some artists and musicians in the community to take their craft away from the city;
- 6. Whereas, Ann Arbor has long been considered a haven for the arts and hosts the largest art fair in the nation and recent studies have confirmed that the arts annually contribute millions of dollars to the local economy and provide thousands of jobs in the greater Ann Arbor area;
- 7. Whereas, 415 W. Washington provides a wonderful opportunity for the display of public art for all to enjoy;

- 8. Whereas, a large portion of the site lies within the floodway. The remainder of the site lies within the floodplain;
- 9. Whereas, the site is not downtown but lies within the boundaries of the Downtown Development Authority;
- 10. Whereas, if it is determined by the citizen committee that the brick building that fronts on Washington and is part of the Old West Side Historic District can be restored in a cost effective manner there is great potential in redeveloping this site as a model of energy efficiency supported by renewable energy;
- 11. Whereas, The building could be made available to artists and others in the community as a place for studios, gatherings, meetings, and performances;
- 12. Whereas, Even in this time of reduced resources for all local governments in Michigan it may be possible to maintain momentum on long term community goals using an innovative approach that conserves and stretches resources;
- 13. Whereas, A collaboration between the City and other organizations in the community affords the best opportunity to make progress on building a new park and arts center that will benefit the City for many years to come;
- 14. Whereas, The Allen Creek Greenway Conservancy was established to work for the creation of a new greenway and to generate funds to facilitate creation of the Greenway;
- 15. Whereas, The Arts Alliance was formed to promote and facilitate the arts in the Ann Arbor area and many other potential partners exist in the community who would be interested in assisting in moving this project forward;

- 16. Whereas, Individuals in the community have recently expressed a willingness to contribute to the development of new parks; and
- 17. Whereas, Funds for a combined Community Arts Center and Greenway Park may be available through grants related to art centers, parks, historic renovation, energy efficiency and renewable energy, brownfield reclamation, floodway restoration, etc.;
- 1. Resolved, That City Council invites the Allen Creek Greenway Conservancy and the Arts Alliance to join with them a citizen committee in exploring the creation of a Greenway Park and Arts Center at 415 W. Washington; to collaborate in assessing the site and with other efforts to accomplish this community goal;
- 2. Resolved, That City Council invites the Allen Creek Greenway and the Arts Alliance to work with them in raising funds for a comprehensive grant search and application process;

Resolved, That City Council Requests that the Downtown Development Authority contribute \$50,000 to assist the citizen committee in finding and applying for grants.

3. Resolved, That City Council asks the Downtown Development Authority, the Parks Advisory Commission, the Art in Public Places Commission, The Energy Commission, the Main St. Area Association, the Office of the County Water Resources Director and other City and community entities and individuals willing to contribute resources and expertise to this effort to be open to collaboration with the City, the Greenway Conservancy and the Arts Alliance; the citizen committee;

4. Resolved, That the Mayor's Office and Council Members Teall and Hohnke will work with government and community partners in exploring the creation of a Greenway Park and Arts Center at 415 W. Washington; and

Resolved, That the committee will be composed of any Ann Arbor resident who desires to participate in this process. Leadership of this committee shall be determined by a vote of the committee. Thee Mayor's Office and City Council will cooperate with this committee in exploring the creation of a Greenway Park and Arts Center at 415 W Washington; and

Resolved, That any permanent use of this site is contingent on an updated watershed study to assess the risk of flooding, and

5. Resolved, That a progress report be delivered to City Council at the first meeting in February, 2011. July.

In an earlier post I gave my views on the talk in Washington about repealing McCarran-Ferguson.

I was called to task by one of our co-bloggers, Mike Feehan, over the source cited and the misspelling of the act. To be honest, when I posted I thought something looked wrong but never bothered to check it out because I was so steamed over the stupidity of those who want to repeal the act. As Mike pointed out, the correct spelling is McCarran, not McCrarran.

He also elaborated, in much less emotional fashion, on what the act really means. Here is his take.

McCarran-Ferguson was enacted primarily to maintain each state's right to regulate insurance issued for its residents. The limited anti-trust exemption under McCarran-Ferguson leaves intact the states' duty to





THE HISTORY

On March 18, 2006 a meeting was called by me with the assistance of friends and associates to address quality of life challenges that are facing African-Americans, including the perennial academic achievement gap between African-Americans and their Caucasian counterparts; the disproportionate incarceration rate of African-Americans, e.g. the imprisonment rate of African-Americans is approximately 60% where as the

population of Blacks is approximately 12% and the unequal income levels of African-American households; which is approximately \$25,000 compared with \$41,000 for Caucasian families. Also, 40% of Black children are poor while only 11% of Caucasian children are poor. Since the original meeting the LOSQ became incorporated with the purpose of finding solutions to the aforementioned problems. During the past three years the LOSQ has conducted programs to address these issues. The website, www.losq.org gives additional information regarding the organization.

THE PURPOSE

The purpose of The Loyal Opposition to the Status Quo, Inc. is to advance the social and economic life of African-Americans and other minorities, through education, communication, rational thought, leadership and community attitudes.

THE LEGAL STATUS OF THE LOSQ

Thank you, Mr. Muckstadt, for your note. I will attempt to address your inquiries, but will copy Fleet and Facilities Manager Matt Kulhanek on my response so that he may complete any "blanks" I leave.

The Ann Arbor Municipal Airport has been in service since before World War II, as I understand it. The Airport is owned by the City of Ann Arbor, although it is technically located within Pittsfield Township. As a manager within the Public Services Area, Matt Kulhanek is also the airport manager. The airport's budget is considered and approved by City Council annually as a part of the overall budget approval process. Like many City managed operations, the airport is self-sufficient financially and not supported by City tax dollars. Recent construction of hangers at the airport was intended to meet a pent-up demand for rental space for aircraft owners, as well as add needed revenues to the airport finances. Like every City run operation, the airport manages a balanced budget.

If I missed anything, I am sure Matt will respond as well.





The Media Frenzy After the State of the Union



If your local representative appeared on television after the State of the Union address, you witnessed a bit of the pageantry that goes on behind the scenes.

The Lawyer Behind Citizens United

He was looking forward to talking about his client, Citizens United, and its efforts to air advertisements for a movie criticizing Hillary Rodham Clinton which officials said violated campaign finance laws.

Only one reporter showed up that day. But Bopp got his turn in the spotlight last week when the U.S. Supreme Court agreed with his arguments .

In a 5-4 decision, the court's conservative wing held that corporations, nonprofits and labor unions could for the first time use their own funds to directly spend money on political ads to influence elections in the crucial days before an election.

Friends,

If you've tracked City government at all, you've probably heard the Mayor, Councilmembers or Staff talk about "buckets" or "funds". You've probably heard us talk about our ability to pay for some services and our inability to pay for other services as if our hands were somehow tied – as if we somehow do not control how to spend taxpayer money. How can this be?

You have also may have looked at City spending and thought "That just doesn't make any sense". You may have heard about the possibility of firefighter layoffs (averted for the time being) while at the same time seen progress on construction of an underground parking structure on the Downtown Library Lot, or heard about investments in single-stream recycling while driving over the degraded Stadium Bridge. How can it be that the City on the one hand can claim revenue distress, while at the same time, go out and begin construction on these other projects? These are reasonable questions. Let me try to answer them.

Multiple Funds

The bottom line is that the rules that govern municipal revenues, expenditures and accounting are very different from the rules that apply to us all as private citizens.

Like you, my family has one checking account – our income gets deposited into that account; our bills get paid from that account. If we need to pay the gas bill, buy groceries, fix the roof, pay the mortgage, it all comes from that one account – that one bucket. In this case, money is truly fungible. If the roof needs fixing, we have less money available for groceries; if our gas bill is low because we've turned down the thermostat, we have more money available for groceries.

The City does not work this way; it cannot work that way.

The City is a highly complex organization with anticipated revenues in excess of \$350M this year. To organize these revenues and their associated expenditures, therefore, the City maintains a variety of separate accounts – called Funds. The City maintains these Funds as separate accounts for a variety of reasons; in some cases it is legally required to only spend certain monies for certain purposes, on other cases, the City has decided to segregate a service function to better understand its operation.

Those are the general principles – let's get to specifics, let me sketch some of these Funds these for you:

General Fund – The General Fund (approx. \$82M in FY 2010) is the chief operating fund of a local government. This fund is primarily funded by taxes (as opposed to user fees) and expends money for activities that are not financially sustainable without support for taxes. For example:

- Police
- Fire
- Most park operations (e.g., mowing the grass)
- Recreation
- 15th District Court

Within the General Fund, monies are indeed fungible – monies not spent on Parks can be spent on Police salaries. In FY 2010, approximately 48% of the General Fund budget goes to Safety Services (Fire & Police).

Special Revenue Funds – The City may establish a Special Revenue Fund to account for the proceeds of specific revenue sources. State or Federal law typically restricts the City's ability to spend monies from these sources to a set of limited areas. Examples include:

- Parks Improvements Millage Restricted by the specific millage language approved by voters.
- Major Streets Revenues come primarily from State gasoline and weight tax.
 The State restricts expenditures to repairs, maintenance and construction on the City's major streets.
- Federal and State Grants monies are legally restricted for the purpose of the specific grant.

These voter-approved taxes or government grants cannot be used for any purpose other than the one designated up front. So, for example, we may appear well funded with "Parks" money by virtue of the Parks Improvement Millage, but because these are "improvements" monies, we cannot use them for "operations" – to mow the grass or groom the baseball fields. Operations monies must come out of the General Fund, where budget pressures are severe.

Enterprise Funds – Enterprise Funds are internal accounting conventions used to account for operations (a) that are financed and operated in a manner similar to private business enterprises – where the City intends that the costs of providing goods or services to the general public on a continuing basis be financed or recovered primarily through user charges; or (b) where it is useful to track revenues earned, expenses incurred, and/or net income for capital maintenance or other purposes. The City utilizes enterprise funds for activities such as:

- Water
- Sanitary Sewer
- Ann Arbor Airport
- Farmer's Market
- Solid Waste
- Golf Courses

The primary benefit of an Enterprise Fund is to give the City the data to determine the profit or loss associated with a particular service. Enterprise Funds also enable us to better plan to meet needed capital improvements in these capital-intensive departments. Water rates, for example, cover the day-to-day cost of water delivered, but because we have created a separate Enterprise Fund, we are also able to determine what rates are necessary to cover long term infrastructure needs, like new treatment plants or water main replacements.

Internal Service Funds – These Funds are used to account for goods and services provided by one City department to other City departments. For example:

- Information Technology
- Fleet Services

These Internal Service Funds provide valuable cost-cutting information. Take this example – software licenses. Software licenses cost the City hundreds of thousands of dollars each year. If that cost were paid for by a General Fund IT line item, there would be little direct incentive for managers throughout the City to be efficient in their use of software. If, however, each manager's budget is charged for each software license used in that area, then managers are going to carefully determine what they need and eliminate wasteful licenses.

OK, so what?

Understanding the 'buckets' enables you to understand that in the City there is often money usable for one purpose, but not usable for another purpose. Understanding the limitations imposed by various Funds helps you understand why the City does what it does.

Take the Library Lot, for example. It seems peculiar that construction on an underground parking structure should begin at the same time as we were nearly required to lay off firefighters (Note that the reprieve is really only for 6 months; the conversation will begin anew this spring). Aren't the firefighters more important than a new structure? Arguably yes, but the money for the Library Lot parking structure could not be used to pay firefighter salaries – the money to pay to construct the structure will come from the parking lot itself through a fund controlled by the Downtown Development Authority ("DDA"). In other words, a decision to forego the Library Lot parking structure would not increase the General Fund – it would not increase the money available to pay for Safety Services or to pay to mow park grass.

Consider too Council's recent decision to invest \$4.5M+ in single-stream recycling. The benefits of this program will be as follows: 1) We would now be able to recycle more materials – all plastic bottles, household plastic containers #1,#2, and #4-7

Deleted: Consider the City's Golf Courses. The City for years ran the Huron Hills and Leslie Golf Courses out of the General Fund, a practice that hid the massive operating losses associated with these amenities. We recently have put the Golf Courses in an Enterprise Fund so that we can better track revenue and costs; they are still huge drains on the budget, but there has been tremendous improvement. ¶

(no styrofoam or #3s), and bulky HDPE such as buckets, crates, toys, trays, and furniture; 2) A RecycleBank rewards system that should net the average household approximately \$240 in consumer-specified coupons redeemable at local businesses; 3) An increase in waste stream diversion from 50% now to 70% in 2010; and 4) A cost savings to the City of between \$500K - \$750K per year.

These are obviously substantial benefits to our community, but you might reasonably observe that these benefits might not be as important to Ann Arbor as, say Stadium Bridge. The money that will be used to fund the single-stream investments, however, cannot be spent on bridge infrastructure – it comes from reserves in the Solid Waste Fund, a fund supported by the Solid Waste Millage and sewage fees. It would be, therefore, illegal to use that money for anything unrelated to waste stream management.

Bottom line.

Running a City is a complex operation subject to legal, contractual and 'best practices' limitations on the freedom of the City to spend tax, user fee and other revenue.

These limitations often result in unbalanced resources – one area of the City's Budget may be deeply underfunded (e.g., the General Fund), whereas another might be secure (e.g., the Water Fund). These limitations prevent the City from freely shifting its resources from flush Funds to impoverished Funds, even though we might all believe it to be a "better" use of those resources. In the end, these restrictions are a fact of life and we will do our best to provide the services that Ann Arbor demands with the resources entrusted to us.

After union members at the Rio Tinto mine in Kern County overwhelmingly reject a contract offer that would have changed seniority rules, the company brings in replacement workers.

PHOTOS: A labor dispute threatens to tear a Kern County mining town apart

The giant Rio Tinto Borax mine in Boron locked out about 540 hourly workers Sunday after the employee union refused to ratify a new labor contract.

The lockout began at 7 a.m. as miners showed up outside the gates and were told they couldn't come in.

Replacements were brought in to do their jobs.

"It's obviously a drastic measure and I am well aware of the fact that this has very real consequences to our employees. It's not a bully tactic, but it's our only real alternative," said Dean Gehring, general manager of the mine.

"We cannot continue operating with this threat of a strike hanging over our head," he said. "I pray this will go fast, but I'm preparing for it to go long."

The Boron operation is the largest open-pit mine in California and the second largest borax mine on Earth.

The Kern County community and the mine have been closely tied for generations, but increasing labor tensions have threatened to sever those bonds.

Many residents work at the mine and fear a strike or extended lockout could cripple the city of 2,000.

"I think it will be pretty traumatic," said Jim Freeman, 54, who has worked at the mine for 31 years.

"I think the company had the impression we were going to roll over and let them feed us the poison."

Rio Tinto, a London-based mining giant with operations on five continents, has been negotiating with the International Longshore and Warehouse Union Local 30, which represents the employees, since September. The company says it has lost 25% of its global borax share and needs to make changes to stay competitive.

It has offered the union a 2% wage increase, an annual performance bonus, a \$4,000 signing bonus and 80% coverage of healthcare costs. In return, Rio wants to hire more nonunion employees and, more importantly, change the seniority system so that it can promote people based on skill and performance rather than just years of service. The company threatened a lockout if there was no deal by Sunday.

"We are asking for a lot of changes and we know that," Gehring said. "Some employees think the flexibility we are looking for will take away seniority."

He added that running the business with a contingency workforce means the company will not be negotiating "any time in the near future."

The union says the proposed seniority changes will lead to nepotism.

Members met Saturday night to discuss the proposals.

"After hours of analyzing and evaluating the contract, every one of the 500 workers at the meeting voted no,"

said union spokesman Craig Merrilees. "The contract would allow the right to discriminate and practice cronyism when it comes to deciding who gets a raise, who gets overtime and who gets training opportunities."

Workers spent much of Sunday organizing committees to ensure locked-out employees have enough food and basic necessities for the days or weeks ahead. Calls have come in from around the state offering donations, officials said.

"People here are tough and willing to see this through to the end," Merrilees said. "It's not just about Rio Tinto but all the companies doing this to people across the country. In this little town people are drawing the line."

The U.S. and its unruly Latin American 'backyard'

U.S. aggressiveness towards the Venezuelan, Bolivian, and Ecuadorian governments has increased in response to diminishing U.S. influence over the Latin American and Caribbean area, which Washington has been blaming on Hugo $Ch\tilde{A}_1$ vez in particular (and also on Cuba, but Cuba is a much older story).

Several examples illustrate the United States' waning control

During the negotiations that followed Colombia's attack on Ecuador on 1 March 2008, [1] instead of appealing to the Organization of American States (OAS) of which the United States is a member and which is headquartered in Washington, the Latin American presidents held a meeting in Santo Domingo, within the framework of the Rio Group, [2] without inviting their great neighbour from the North, and clearly laid the blame on Colombia, a U.S. ally. In 2008, Honduras -- traditionally and wholly subordinated to U.S. policy-joined Petrocaribe, which was created on the initiative of Venezuela to provide oil to the non-exporting countries in the region at a lower price than that practised on the world market. Honduras also joined the Bolivarian Alliance for the Americas (ALBA), another initiative for regional integration launched by Venezuela and Cuba. In December 2008, another important summit took place bringing together most of the Latin American presidents in Salvador de BahÃa, with the noteworthy presence of the Cuban Head of State, Raul Castro, next to whom was seated the Mexican president, Felipe Calderon, who until recently had adopted a hostile attitude towards Cuba, to keep in line with the directives from Washington. A few months later, the OAS decided, in spite of U.S. opposition, to reintegrate Cuba, which had been excluded in 1964. In 2009, Ecuador also joined ALBA, and terminated the U.S. armyâ e^{m} s lease of the Manta air base.

Washington has systematically attempted to thwart the shift towards the left

As the following examples illustrate, since the beginning of the 2000s Washington has systematically attempted to thwart the shift towards the left made by the peoples of Latin America: supporting the coup d'Etat against Chavez in April 2002, offering massive financial support to the anti-Chavez opposition movement, supporting the Venezuelan bosses' strike from December 2002 to January 2003, the active intervention of the U.S. ambassador in Bolivia to prevent the election of Evo Morales, the World Bank's remote control intervention in Ecuador in 2005 to obtain the resignation of Rafael Correa, who was then the Minister of Economy and Finance, the organization of joint military operations in the Southern Cone,[3] the resurrection of the Fourth Fleet,[4] and a very significant increase in military aid to its Colombian ally, which serves as a bridgehead in the Andean region. In addition, to overcome the failure of the FTAA (Free Trade Area of the Americas) in November 2005, Washington has been negotiating and/or signing as many bilateral free trade agreements as possible (with Chile, Uruguay, Peru, Colombia, Nicaragua, Dominican Republic, El Salvador, Guatemala, Honduras, and Costa Rica).

Coup d'Etat in Honduras

U.S. aggressiveness towards what it sees as a dangerous "Chavist contagion†in Latin America went up another notch in June-July 2009 with the military coup d'Etat in Honduras, which overthrew the liberal president Manuel Zelaya just as he was calling for a referendum on the election of a constituent assembly by universal suffrage. The Pentagon had resented this shift to the left by a president it thought would behave obediently

because Honduras is one of its subordinate countries in the region. If a constituent assembly had been elected by universal suffrage, it would have inevitably had to rule on the demand for agrarian reform, which would have called into question the enormous privileges of the major landowners and foreign agri-business transnationals present in the country. It is mainly for this reason that the local capitalist class, a significant number of whom come from the agrarian sector, supported the coup. It is also important to take account of the fact that this capitalist class is a class of compradors who are completely turned towards import-export business and dependent on good relations with the United States. This explains why it supported the signing of a free trade agreement with Washington and was opposed to ALBA. Zelaya's order for an increase in the minimum wage is also one of the factors that pushed the bosses to plot his overthrow. [5] In addition, we know that Zelaya intended to ask Washington to leave the Soto Cano air base located less than 65 miles from the capital so that it could be converted into a civilian airport. Even imagining $\hat{a} \in \text{``}$ which is highly improbable $\hat{a} \in \text{``}$ that the Honduran generals acted on their own initiative in collaboration with the local capitalist class, it is inconceivable that Roberto Micheletti, the puppet president designated by the military and by corporate and liberal party leaders, could have stayed in power if the U.S. government had vigorously opposed it. The U.S. has been training Honduran generals for decades, and has an important military base in Soto Cano (with 500 American soldiers stationed there on a permanent basis); moreover, as Hillary Clinton admitted after the coup, the U.S. has massively funded the opposition to President Zelaya.[6] In addition, U.S. transnational companies, particularly in the agri-business sector, are wellestablished in this country, which they consider to be a banana republic.

The seven U.S. military bases in Colombia

In order to further increase the threat against Venezuela and Ecuador, Washington got President à lvaro Uribe to announce in July 2009 that seven Colombian bases would be handed over to the American army, thereby enabling their fighter aircraft to reach all regions of the South American continent (except Cape Horn).[7] It is no coincidence that only a short time separated the military coup in Honduras and the Colombian President ${\bf \hat{a}} {\bf \in ^{M}} {\bf s}$ announcement: Washington was clearly indicating that it wanted to immediately halt the extension of ALBA and nip this 21st century socialism in the bud. It would be irresponsible to underestimate Washingtonâ \in ^ms capacity to do damage, or the continuity characterizing U.S. foreign policy in spite of the election of Barack Obama and a softer rhetoric. While President Manuel Zelaya, who returned to his country secretly on 21 September 2009, was taking refuge in the Brazilian embassy in Tegucigalpa and the putschists were violently repressing demonstrations by partisans of the constitutional President, closing down opposition media, and on September 27 declaring a 45-day state of siege, all that Lewis Amselem, no. 2 representative of Washington at the OAS, had to say was: $\hat{a} \in \mathbb{Z}$ elaya $\hat{a} \in \mathbb{M}$ s return is irresponsible and foolish. $\hat{a} \in \mathbb{M}$ Meanwhile, for several days Hillary Clinton failed to condemn the extended curfew imposed by Micheletti to prevent people from gathering in front of the Brazilian embassy.

The agreement reached on 30 October under the auspices of Washington between representatives of Manuel Zelaya and those of Roberto Micheletti expressly stipulated that the parties undertake not to call either directly or indirectly for the convocation of a constituent assembly or for any consultation of the people (point 2 of the agreement). In addition, it did not explicitly allow for the return of Manuel Zelaya to the presidency of Honduras in order to finish his term (which is due to end in January 2010). Roberto Micheletti and his partisans then decided not to restore the presidency to Zelaya, who then appealed to the population not to participate in the general elections called for 28 November 2009. The main left-wing candidate for the presidency, Carlos Reyes, together with a hundred or so candidates from different parties (including a sector of the liberal party), withdrew his candidature. On 10 November 2009, an embarrassed Washington announced at a meeting of the OAS that it would recognize the results of the elections of 29 November 2009. On the eve of the elections, human rights organizations had recorded the assassination of more than twenty political opposition activists since the coup $d\hat{a} \in \mathbb{R}$ 211 people injured during the repression, close to 2,000 cases of illegal detention, two attempted kidnappings and 114 political prisoners accused of sedition. Media opposing the coup were either shut down or harassed. The UN, the OAS, the European Union, UNASUR, the member countries of the Rio Group and ALBA had decided not to send observers. Estimates of the number of citizens who did not vote vary, depending on the source. According to the pro-putschist electoral Supreme Tribunal, the percentage of non-voters was 39%, while several independent organizations advance figures between 53% and 78%. In spite of this, State Department spokesman Ian Kelly considered these illegal and fraudulent elections "a necessary and important step forward.†[8] Washington

recognized the election to the presidency of Porfirio Lobo of the National Party, a hardline representative of the property barons and the political right who organized the coup d'Etat. The U.S.

Ambassador in Tegucigalpa declared that the elections were âcœa great celebration of democracyâc and said the U.S. would work with Porfirio Lobo, whose nickname is Pepe. â cœpepe Lobo is a man of great political experienceâc, Ambassador Llorens told HRN radio. âcœI wish him luck, and the United States will work with him for the good of both our countries. [...] Our relations will be very strong.âc

While the Honduran parliament decided on 2 December 2009 not to restore President Zelaya to office up to the end of his term on 27 January 2010, Washington continues to support the process put in motion by the putschist government. [9] This creates an extremely serious precedent because Washington has repeatedly stated that the ousting of Zelaya definitely constituted a coup dâc Etat. [10] Supporting an electoral process stemming from a coup dâc Etat and working to promote international recognition of both the authorities that perpetrated the coup and those benefiting from it gives clear encouragement to putschist aspirants who choose to rally to the Washington camp. This clearly applies to a large number of right-wing people in Paraguay.

Paraguayan President Fernando Lugo could be overthrown

In December 2009 the liberal senator Alfredo Luis Jaeggli, chair of the domestic commission and of the budget commission, called President Fernando Lugo to be overthrown, whom he charged with wishing to enforce the Chavist model of 21st century socialism, like Manuel Zelaya. Alfredo Jaeggli, whose party belongs to the current government and represents its main 'support' in parliament, claims that the coup in Honduras was not really a coup. He sees the overthrow of Manuel Zelaya, and what has been done by the de facto regime since, as perfectly legal.[11] He would like the Paraguayan parliament to initiate a political trial against Fernando Lugo, so as to remove him from his function and replace him with the Republic's Vice-president, namely the right-wing liberal Federico Franco. Senator Jaeggli's complaint has nothing to do with Lugo's moral behaviour, his attack is focused on his political options. He complains that he does not follow the lead of countries that carried out a successful economic reform, such as Chile under Pinochet and Argentina under Carlos Menem. [12] Clearly, Honduras can easily become a dangerous precedent as it opens the door to military coups condoned by some state institutions, such as the parliament or the Supreme Court.

Conclusion

In the light of this experience, we can see that the Obama administration is in no hurry to break with the methods used by its predecessors: witness the massive funding of different opposition movements within the context of its policy to $\hat{a}\in \mathbb{C}$ strengthen democracy $\hat{a}\in [13]$ the launching of media campaigns to discredit governments that do not share its political agenda (Cuba, Venezuela, Bolivia, Ecuador, Nicaragua, Manuel Zelaya $\hat{a}\in \mathbb{N}$ Honduras and so on), maintaining the blockade of Cuba, the support for separatist movements in Bolivia (the media luna and the regional capital, Santa Cruz), in Ecuador (the city of Guayaquil and its province), and in Venezuela (the petroleum state of Zulia, the capital of which is Maracaibo),[14] the support for military attacks, like the one perpetrated by Colombia in Ecuador in March 2008, as well as actions by Colombian or other paramilitary forces in Venezuela.

The recent dispatch of 10,000 soldiers to Haiti in the wake of the January 2010 earthquake, as well as the potential support for a constitutional coup d'Etat planned by some sectors of the Paraguayan right to overthrow President Fernando Lugo in 2010, are among other threats posed by the U.S. policy in Latin America and the Caribbean that should be paid attention to in the coming weeks.

I had lunch with Howard Zinn just a few weeks ago, and I've seldom had more fun while talking about so many matters that were unreservedly unpleasant: the sorry state of government and politics in the U.S., the tragic futility of our escalation in Afghanistan, the plight of working people in an economy rigged to benefit the rich and powerful. Mr. Zinn could talk about all of that and more without losing his sense of humor. He was a historian with a big, engaging smile that seemed ever-present. His death this week at the age of 87 was a loss that should have drawn much more attention from a press corps that spends an inordinate amount of its time obsessing idiotically over the likes of Tiger Woods and John Edwards.

Mr. Zinn was chagrined by the present state of affairs, but undaunted. "If there is going to be change, real change," he said, "it will have to work its way from the bottom up, from the people themselves. That's how change happens."

We were in a restaurant at the Warwick Hotel in Manhattan. Also there was Anthony Arnove, who had worked closely with Mr. Zinn in recent years and had collaborated on his last major project, "The People Speak." It's a film in which well-known performers bring to life the inspirational words of everyday citizens whose struggles led to some of the most profound changes in the nation's history. Think of those who joined in -- and in many cases became leaders of -- the abolitionist movement, the labor movement, the civil rights movement, the feminist revolution, the gay rights movement, and so on.

Think of what this country would have been like if those ordinary people had never bothered to fight and sometimes die for what they believed in. Mr. Zinn refers to them as "the people who have given this country whatever liberty and democracy we have."

Our tendency is to give these true American heroes short shrift, just as we gave Howard Zinn short shrift.

In the nitwit era that we're living through now, it's fashionable, for example, to bad-mouth labor unions and feminists even as workers throughout the land are treated like so much trash and the culture is so riddled with sexism that most people don't even notice it. (There's a restaurant chain called "Hooters," for crying out loud.)

I always wondered why Howard Zinn was considered a radical. (He called himself a radical.) He was an unbelievably decent man who felt obliged to challenge injustice and unfairness wherever he found it. What was so radical about believing that workers should get a fair shake on the job, that corporations have too much power over our lives and much too much influence with the government, that wars are so murderously destructive that alternatives to warfare should be found, that blacks and other racial and ethnic minorities should have the same rights as whites, that the interests of powerful political leaders and corporate elites are not the same as those of ordinary people who are struggling from week to week

to make ends meet?

Mr. Zinn was often taken to task for peeling back the rosy veneer of much of American history to reveal sordid realities that had remained hidden for too long. When writing about Andrew Jackson in his most famous book, "A People's History of the United States," published in 1980, Mr. Zinn said:

"If you look through high school textbooks and elementary school textbooks in American history, you will find Jackson the frontiersman, soldier, democrat, man of the people -not Jackson the slaveholder, land speculator, executioner of dissident soldiers, exterminator of Indians."

Radical? Hardly.

Mr. Zinn would protest peacefully for important issues he believed in -- against racial segregation, for example, or against the war in Vietnam -- and at times he was beaten and arrested for doing so. He was a man of exceptionally strong character who worked hard as a boy growing up in Brooklyn during the Depression. He was a bomber pilot in World War II, and his experience of the unmitigated horror of warfare served as the foundation for his lifelong quest for peaceful solutions to conflict.

He had a wonderful family, and he cherished it. He and his wife, Roslyn, known to all as Roz, were married in 1944 and were inseparable for more than six decades until her death in 2008. She was an activist, too, and Howard's editor. "I never showed my work to anyone except her," he said.

They had two children and five grandchildren.

Mr. Zinn was in Santa Monica this week, resting up after a grueling year of work and travel, when he suffered a heart attack and died on Wednesday. He was a treasure and an inspiration. That he was considered radical says way more about this society than it does about him.

U.S. philanthropist gives modern art to Cuba Last Updated: Thursday, January 28, 2010 CBC News

An American-born philanthropist and curator has donated 120 works of modern art, including pieces by Pablo Picasso, Joan Miro and Marcel Duchamp, to Cuba's National Museum of Fine Art.

Gilbert Brownstone, 69, is based in France and says he admires Cuba because it has advanced the culture of its people.

"I think I can help in this fight," he said in an interview with Agence France-Presse. "I will continue buying and donating works from the collection to the Cuban people."

On Monday, he delivered engravings and drawings by Andy Warhol, Roy Lichtenstein, Andre Masson, Edouard Vuillard, Camille Pissarro and others to the museum in Havana.

Brownstone was a curator of the Picasso Museum in Antibes and worked at a modern art gallery in Paris. He amassed his own collection, held by the Brownstone Foundation, which lends works to public institutions and has donated art to the the Museum of Modern Art in New York and the Centre Georges Pompidou in Paris.

The foundation has also promoted dance in Cuba, creating a new rehearsal space at the Havana Dance Center and funding video projects in Cuba.

Cuba has pledged to tour his collection throughout the island, so all Cubans can enjoy it. Cuban artists of the early 20th century embraced modern art and there are significant collections of modern art in Cuban art institutions.

Brownstone has dual Swiss-American citizenship, which smooths the way for his travels in Cuba, as the U.S. broke off ties with Cuba in 1961.

Fifty years ago, four men stood up by sitting down

"Nothing has ever happened to me since then that topped that good feeling of being clean and fully accepted and feeling proud of me." -- Joseph McNeil, one of four college students who sat at a Greensboro, N.C., lunch counter on Feb. 1, 1960

GREENSBORO, N.C. - The four college freshmen walked quietly into a Greensboro dime store on a breezy Monday afternoon, bought a few items, then sat down at the "whites only" lunch counter -- and sparked a wave of civil rights protest that changed America.

Violating a social custom as rigid as law, Franklin McCain, Joseph McNeil, Ezell Blair Jr. and David Richmond sat near an older white woman on the silver-backed stools at the F.W. Woolworth. The black students had no need to talk; theirs was no spontaneous act. Their actions on Feb. 1, 1960, were meticulously planned, down to buying a few school supplies and toiletries and keeping their receipts as proof that the lunch counter was the only part of the store where racial segregation still ruled.

"The best feeling of my life," McCain said, was "sitting on that dumb stool."

"I felt so relieved," he added. "I felt so at peace and so self- accepted at that very moment. Nothing has ever happened to me since then that topped that good feeling of being clean and fully accepted and feeling proud of me."

They weren't afraid, even though they had no way of knowing how the sit-ins would end. What they did know was this: They were tired, they were angry and they were ready to change the world.

The number of protesters mushroomed, reaching at least 1,000 by the fifth day. Within two months, sit-ins were occurring in 54 cities in nine states. Within six months, the Greensboro Woolworth lunch counter was desegregated.

The sit-in led to the formation in Raleigh of the Student Nonviolent Coordinating Committee, which became the cutting edge of the student direct-action civil rights movement. The demonstrations between 1960 and 1965 helped pass the 1964 Civil Rights Act and the 1965 Voting Rights Act.

"Greensboro was the pivot that turned the history of America around," says Bill Chafe, Duke University historian and author of "Civilities and Civil Rights:

Greensboro, North Carolina and the Black Struggle for Freedom."

On Monday, the 50th anniversary of that transformative day, the International Civil Rights Center and Museum will open on the site of the Greensboro Woolworth store. The dining room is still there, with two counters forming an L-shape. One counter is a replica because the fixture was divided into parts and sent to three museums, including the Smithsonian. But the original stools and counter remain where the four sat and demanded service.

The building remains because two men -- county commissioner Skip Alston and city council member Earl Jones -- arranged to buy it in 1993 for \$700,000 from a bank that planned to turn the space into a parking lot.

"It is my fervent wish, hope and desire that this great edifice ... will be a grand monument to the struggle of all people who strive for freedom," said Blair -- now named Jibreel Khazan -- in a telephone interview. He took the new name in 1968 and has worked as a teacher, counselor, motivational speaker and storyteller.

McCain went on to become a research chemist and sales executive, while McNeil retired as a two-star major general from the Air Force Reserves in 2001 and also worked as an investment banker. Richmond died in 1990.

The four freshmen at N.C. A&T State University were part of an NAACP youth group started by Ella Baker, known as the mother of SNCC. They spent much of the fall semester discussing how to fulfill the promise of the 1954 Supreme Court decision in Brown v. Board of Education.

Other sit-ins had occurred. But they didn't catch fire the way the one in Greensboro did.

The time was right, Chafe says: Six years had passed since the Brown decision, but little had changed. And the place was right as well: Greensboro's white leaders believed theirs was a progressive city and they wouldn't stomach brutality.

The "sixties" were born on Feb. 1, 1960, 50 years ago this week, when four African American college students staged the first sit-in at a segregated lunch counter in Greensboro, N.C. Since then, the mythology of the '60s has dominated the idea of youthful activism.

Of the three big events of the early civil rights movement -- the 1954 Brown vs. Board of Education decision, the 1955-56 Montgomery bus boycott and the sit-ins -- the sit-ins have always been the least understood and, yet, the most important for today's young activists.

We forget how troubled the civil rights movement was in January 1960. It was six years after Brown, but fewer than 1 in 100 black students in the South attended an integrated school. And during the four years after the end of the bus boycott, Martin Luther King Jr. struggled to build on that victory. Many worried that the civil rights movement had ground to a halt. Then Greensboro changed everything.

In the time before Twitter, the rapid spread of the sit-ins was shocking. The first sit-in was an impulsive act, led by college students. They spread to Nashville, Atlanta, Miami, Durham, N.C., and Little Rock, Ark. -- more than 70 cities and towns in eight weeks. By summer, more than 50,000 people had taken part in one.

At the time, this was not just the largest black protest against segregation ever; it was the largest outburst of civil disobedience in American history. The sit-ins rewrote the rules of protest. They were remarkably egalitarian: Everyone participated; everyone was in equal danger. And they went viral because they were easy to copy. All one needed for a sit-in was some friends and a commitment to a few simple principles of nonviolent protest.

Most important, the sit-ins were designed to highlight the immorality of segregation by forcing Southern policemen to arrest polite, well-dressed college students sitting quietly just trying to order a shake or a burger. The students believed deeply in Thoreau's idea that the only place for a just person in an unjust society is jail.

The contrast with King's early efforts was stark. He had worked hard during the bus boycott to prevent arrests. To his thinking, only protests that remained within the bounds of the law could win the war against Jim Crow. The NAACP similarly believed in the power of the courts to end school segregation. But such efforts were so bureaucratic that ordinary African Americans often felt more like observers than participants.

To their African American contemporaries, the college students seemed the unlikeliest group to revive the civil rights movement. Just three years earlier, E. Franklin Frazier, the eminent black sociologist, had condemned them for believing that "money and conspicuous consumption are more important than knowledge." What did Frazier miss?

He failed to see how the comfort of postwar affluence and popular culture bred agitation and activism as easily as it did indifference and apathy. The sit-ins owed more to Little Richard and Levi's than to Jesus and the Bible.

Youth culture in the '50s often made it seem that generation mattered more than race. After all, weren't African American couples sharing the dance floor with white ones on the hit teen show "American Bandstand"?

Yet, in their everyday lives, black teens still felt the sting of segregation. The first thing the Greensboro Four did before starting their sit-in at Woolworth's was to purchase some school supplies at the store. If their money was good enough for pencils, why weren't they good enough to have a seat at the counter?

To many Americans, the sit-ins were unnerving. In a 1961 Gallup Poll, 57% of those who responded said the protests hurt the civil rights movement. Black elders such as King and NAACP head Roy Wilkins tried to control the sitins by co-opting the students as junior partners.

The students instead formed their own organization, the Student Nonviolent Coordinating Committee. SNCC soon emerged as the most dynamic, creative and influential civil rights organization in the '60s. It produced a generation of black leaders, including John Lewis, Julian Bond, Bob Moses, Stokely Carmichael, Marion Barry and dozens of others.

SNCC took the movement to the most violent reaches of the Deep South. Its aggressive tactics -- the courting of arrests and the willingness to risk beatings -- forced the confrontation with racial segregation that compelled congressional intervention. The great milestones of the movement -- the freedom rides, Freedom Summer, Selma, Birmingham -- grew from the tactical innovation of the sit-ins. King may have stirred the nation's soul with the movement's poetry, but SNCC moved it to action with the prose of its grass-roots organizing.

Fifty years later, my students tend to see SNCC's members as mythic figures, a "greatest generation" of activists whose achievements they cannot equal. But I remind them of what they have in common with the SNCC generation. Both have been condemned by adults for their materialism, pop culture and assumed political apathy. Both grew up in a period of relative prosperity that left them comfortable but also unsatisfied. Both came of age when new forms of communication -- TV then, the Internet now -- unsettled politics.

There are many lessons from the sit-ins relevant to the lives of today's young people. Before it was a bumper sticker, SNCC lived out the true meaning of "think globally, act locally." But the most important lesson is to stop looking at the '60s as the manual for modern activism. What made the sit-ins so powerful is how they broke away from the prevailing wisdom to create a new model for change. Look forward, not back, I tell them. It's not your parents' movement anymore.

Subject: NO MONEY FOR AIRPORT!!!

Dear Councilmembers Kunselman and Taylor,

It has been called to my attention that the city council intends to vote tomorrow on the transfer of funds in the amount of \$37,000 to support the Ann Arbor Municipal Airport. I am a resident in your ward and write this email this late Sunday evening to urge you to vote NO! on this resolution and any other forthcoming resolutions that would support the airport and/or any plans to expand the airport.

It seems clear from the data and research already done that such an expansion will do nothing to improve safety at the airport and will allow more, larger aircraft to fly in and out of the airport. It has been shown that the airport expansion will not serve the community but rather a select few private enterprises. As a taxpayer and homeowner on the near southeast side of the city, this is a completely unacceptable outcome. This is not a fair use of taxpayer dollars, especially at a time when we are having to cut basic services at the level of city and county government, not to mention our public schools.

Already we are greatly disturbed by the frequency and proximity of aircraft flying over homes, neighborhoods, parks and schools/playgrounds where we live and our children learn and play, along with the noise and air pollution they bring. From our own personal experience,

there is a vast different in the environmental quality of our immediate surroundings between the home we live in now, near Stadium and Packard, and the home we lived in for 6 years prior to this, near Dexter and Maple. After living in our current home for 7 years, we still have not become "accustomed" to the environmental assault perpetrated on our daily lives by the flight paths of aircraft to and from the Ann Arbor Airport, and the medical flights in and out of the U of M hospital. Do we not deserve the same environmental quality as the rest of the residents in this city?

In the current economy, there is no way we can 1)spend taxpayer dollars to support an airport that is purportedly self-sufficient and 2) risk eroding property values in this area of the city even further due to more and larger aircraft arriving and departing the airport. These larger aircraft already have more than sufficient take-off and landing options very near our city, at Willow Run, and Detroit Metro.

I trust that you will support and protect the residents in the city that live closest to the airport and its effects and work to convince the rest of the city council as to these reasons why we, as citizens, taxpayers, and government leaders of the City of Ann Arbor, simply cannot spend public funds on airport expansion and allow further detriment to our environmental quality.

Thank you for your time, I'll be watching to see what the council decides.
