An advocate for the homeless population urged Council to find alternatives to armed police officers when responding to mental health calls.

Louis Vasquez, resident, thanked Mayor Taylor for the recent veto on the Conor O'Neills event. He urged residents to buy gift cards to support local businesses.

Eric Sturgis, resident, expressed concern about late additions to the Council agenda.

Trische Duckworth, of Belleville, MI, spoke about racism in the public schools.

COUNCILMEMBER HAYNER

Councilmember Hayner stated he called for order regarding a Roll Call Vote because the Rules were not followed, and the City Clerk was interrupted.

COUNCILMEMBER RAMLAWI

Councilmember Ramlawi stated he comes to the meetings prepared, but does not appreciate late additions to the agenda, noting that he and others work over the weekends.

COUNCILMEMBER GRAND
