Dear Ann Arbor City Council Members, especially Council Members Grand and Radina,

I am writing in support of the Thrive Collaborative's proposed Canopy development for Mr. Weber's property at 2857 Packard.

I hope Council will quickly engage with both the Thrive Collaborative (to better understand the proposed project) and Mr. Weber (to gain his confidence in the viability of this proposal and avert a sale to a conventional developer).

My neighbors and I are excited by this creative proposal! It meets many of our city's stated goals and values, provides needed high density housing, is sensitive to our climate crisis, and is welcomed by the surrounding community. It retains many more landmark trees and natural features than the previously approved development for this site, and handles storm water onsite.

The Thrive Collaborative is clearly a values-driven developer, as opposed to the solely profit driven. This unique development will be in harmony with the spirit of the neighborhood and the unique flavor and personality of Ann Arbor. It can serve as an example of a unique approach to building and community.

The proposal balances private development of one part of the land with a City purchase and protection of the other part. This is great use of some of the Greenbelt or Natural Area funds. Although this land doesn't "score" as highly as we would like on the city's evaluation tool, I encourage Council to think outside the box and realize that there are social and network/side-effect benefits to this purchase beyond the preservation of the land itself, that are not necessarily captured by the numeric score.

Acting quickly and boldly will be required to make this happen. The likely alternative is a soul-less, backward-looking development like what was originally proposed by the Peter's project. We are counting on you to grab this chance before it slips away.

Thank you **so much** for putting the resolution forward to determine what, if any changes can be made to the Consent Judgement relating to 2857 Packard. A few questions raised by my neighbors, and one of my own, that we hope will be addressed this evening:

Who or what group needs to submit a formal request to city council to amend the Consent Judgment so that an alternative development can be pursued? Or does the resolution itself accomplish that next step?

Several folks have asked how you or city staff or city lawyers define "feasibility" of an alternative development.... Or does staff (presumably both planning and legal) simply give council information and <u>council</u> decides whether the new information meets a <u>council</u> definition of feasibility? If the latter, do citizens have a chance to weigh in on 'feasibility' definitions?

When will information be returned to Council? Several folks have asked for a 'date certain' to be added to the resolution, as the owner is said to desire some concrete sign or signal that this is being addressed in a timely manner, so that he does not entertain another developer's proposal to build out the existing PUD simply to get his pay out sooner....

Also, please note that the date on the consent judgement document attached to the resolution seems incorrect - it reads 2000 (we are thinking it should be 2019 or 2020?)
I look forward to your discussion this evening :)
