#### H COMMISSION PROPOSED BUSINESS

H-1 <u>21-0548</u> Resolution to Recommend Approval of a Contract with E.T. Mackenzie Company to Renovate the Border-to Border Pathway between the Gallup Park Vehicle Bridge and Mitchell Field Bridge (\$646,595.50)

Adam Fercho, City of Ann Arbor Park Planner & Landscape Architect presented the proposed resolution.

Moved by Smith, seconded by Appel to approve the Resolution to Recommend Approval of a Contract with E.T. Mackenzie Company to Renovate the Border-to Border Pathway between the Gallup Park Vehicle Bridge and Mitchell Field Bridge. On a roll call vote, the vote was as follows with the Chair declaring the resolution approved.

Approved Resolution Reads as Follows: Whereas, The Border-to-Border pathway in Gallup Park is in need of major renovation,

Whereas, The Parks and Recreation Open Space Plan (PROS) recommends infrastructure improvements for pathways that are in disrepair;

Whereas, Funding for the Gallup Park Pathway Renovations is available in the approved FY2021 Park Maintenance and Capital Improvements Millage budget;

Whereas, Competitive bids were received by Purchasing on March 2, 2021;

Whereas, E.T. Mackenzie Co. submitted the lowest responsive bid;

Whereas, E.T. Mackenzie Co. has submitted all required Non-Discrimination, Prevailing Wage, Living Wage, and Conflict of Interest Disclosure forms and complies with the requirements of the City's Non-Discrimination, Prevailing Wage, and Living Wage Ordinances;

RESOLVED, That the Park Advisory Commission recommends approval of a \$646,595.50 contract with E.T. Mackenzie Co. to renovate the Border-to-Border pathway in Gallup Park between the Gallup Vehicle Bridge and Mitchell Bridge, and approve a construction contingency of \$64,659.55 (10%) to cover potential contract change orders for a total contract amount of \$711,255.05 for the life of the project without regard to fiscal year.
